(Hereinafter called the “Union”)**

ARTICLE 1 – PREAMBLE TO AND PURPOSE OF THE AGREEMENT

- 1.01 It is the intent and purpose of the parties hereto that this agreement shall:
- a) Protect and continue to improve the interests of the employees and the Company.
 - b) Provide for the prompt and peaceful adjustment of differences which may arise between employees and the Company.
 - c) Ensure harmonious and efficient operation of the plant.
 - d) Set forth the rates of pay, hours of work and working conditions as are included in this agreement.

ARTICLE 2 – SCOPE

- 2.01 The Company recognizes the Union as the sole and exclusive collective bargaining agency for all employees covered under this Agreement.

ARTICLE 3 – RECOGNITION

- 3.01 The Company recognizes the Union, UNIFOR and its Local 1101, as the exclusive bargaining agent of its employees covered under the scope clause, with respect to wages, hours and working conditions as are included in this Agreement.

ARTICLE 4 – DISCRIMINATION

- 4.01 There shall be no discrimination, harassment, restriction, or coercion in respect of an employee or employer exercising any right conferred under this agreement or any law of Canada or Ontario.

ARTICLE 5 – BARGAINING UNIT WORK

- 5.01 Supervisory employees shall not be permitted to perform work on any hourly rated job except in the following situations: in emergencies which call for immediate action to avoid interruption of operations; troubleshooting; in the instruction or training of employees/trainers, including demonstrating the proper method to accomplish the task assigned; as well as commissioning activities.
- 5.02 Before any work would be contracted out that is presently performed by bargaining unit employees the Maintenance Manager or their designate will meet with the Skilled Trades Chairperson or their designate on a bi-weekly basis to discuss any such work scheduled to be performed by an outside contractor. The Company will explain its reasons for subcontracting the work and give the local union an opportunity to suggest ways in which the work might otherwise be performed. The Company will give due consideration to the suggestions

of the Union before making its final decision as to whether or not such work will be subcontracted. Should any jobs be eliminated, the affected employees would be displaced through attrition.

- 5.03 The Company will review the status of any laid off employees on a case by case basis and determine if there is any applicable bargaining unit work that can be performed by them at the rate assigned to the designated work. Final approval shall be determined by the Plant Manager or his/her designee.

ARTICLE 6 – UNION SECURITY

- 6.01 All employees who, on the effective date of this Agreement are members of the Union in good standing in accordance with its constitution and by-laws, and all employees who become members after that date shall, as a condition of employment, maintain their membership in the Union in good standing for the duration of this Agreement.
- 6.02 When new employees are required, any so employed shall, upon completion of their probationary period, become and remain members, in good standing of the Union.
- 6.03 The parties agree that the above clause will be exercised in a manner consistent with the Labour Relations Act of the Province of Ontario.
- 6.04 Union Representatives shall be regular full time employees of the Company and may be selected in any manner determined by the Union. Two four hour blocks per week will be allotted for the Union President or any designated representative of the Union to conduct Union business.
- 6.05 The Union shall keep the Company advised in writing with up-to-date lists of the names of Union Representatives and any other representatives of the

Union who are authorized to act in adjusting grievances or in transacting other official Union business. The Company agrees to recognize only those representatives whose names have so been submitted in writing.

- 6.06 The Company will recognize a Union-appointed Negotiating Committee which, when meeting with Company representatives shall consist of not more than seven (7) full time employees of the Company and the National Representative.
- 6.07 The 7:00 a.m. to 3:00 p.m. shift Monday to Friday will be a permanent shift for the office of the Union President. In cases where the President is unavailable due to scheduled vacation or other absences, for one (1) week or more, a designated official of the Union will take his/her place on the day shift Monday to Friday.

ARTICLE 7 – CHECK OFF OF UNION DUES

- 7.01 The Company agrees to deduct from the pay of the employee the monthly Union dues upon receipt of an authorized form duly signed by the employee making the request and witnessed by a representative of management. The Union will be provided the opportunity to meet new employees during their orientation program, and the union will be given up to 2 hours with new employees.
- 7.02 The Union shall notify the Company, in writing, of the prevailing rate of Union dues.
- 7.03 If the total amount earned in excess of all other authorized deductions by the employee, for the pay period in which the dues are deducted, is less than the regular monthly dues, no deduction will be made for that month by the Company.
- 7.04 The Company agrees to deduct delinquent dues upon receipt by the Human Resources Manager, of a list from

the Union.

- 7.05 The amount deducted will be forwarded by the 15th day of the month wherever possible to a designated officer of the local Union.
- 7.06 Regular union dues as defined by section 47 of the Labour Relations Act, 1995 will be deducted from the wages of probationary employees by the Company and remitted to the Union at the same time as are union dues in respect of permanent employees. This provision does not require probationary employees to become members of the Union prior to successfully completing their probationary period nor does it in any way alter or affect any other provision or article of this agreement (including without limitation the rest of article 7) relating to probationary employees or any of the Company's rights in respect to probationary employees.

ARTICLE 8 – ACCESS TO PREMISES

- 8.01 Properly authorized representatives of the Union will be permitted to enter the premises for the purpose of interviewing employees, handling complaints, disputes or grievances or working conditions. It is understood that such representatives, before entering the premises, shall notify the employer of their desire for admittance for such purposes. There shall be no interference with production.

ARTICLE 9 – NO STRIKES

- 9.01 There shall be no strikes, walkouts, slowdowns or sitdowns by the Union, or lockout by the Company during the life of this Agreement. It shall not be considered a violation of this Agreement if members of Local 1101 refuse to pass a legally established picket line when or if a legal strike is called by another Union.

ARTICLE 10 – RELIEF FOREPERSON

- 10.01 The Union agrees that the selection of the employee to replace supervision on a temporary basis shall be a management prerogative and that seniority will not be considered in any replacement situation. Employees who are chosen to be Relief Forepersons shall be trained as such up to a maximum of three (3) months, and may be used for relief purposes up to one hundred and eighty (180) days per year. If, after one hundred and eighty (180) days, the relief foreperson is scheduled to work such that he would displace a more senior employee, the first employee displaced will be scheduled for the same work week. The one hundred and eighty (180) day restriction will not apply to the Relief Foreperson acting in the scheduling capacity.
- 10.02 An employee who temporarily replaces supervisory employees on vacation or extended absence will receive an additional one dollar (\$1.00) an hour over and above the Bosch rate. When the Company wishes to use an employee in this manner the Union will be notified in writing of the dates involved. If the relief Supervisor holds a pool position and is needed on said pool position, then the Company will add an additional pool position.

ARTICLE 11 – DISCHARGE CASES

- 11.01 The Union will not question the dismissal of any employee until after they have completed their probationary period as per Article 16.01. An employee will be considered on probation until after they have worked for the period mentioned.
- 11.02 A claim by a permanent employee that they have been unjustly discharged from their employment shall be treated as a grievance if a written statement of such grievance is lodged with the Company within seven (7) calendar days after the employee ceases to work for the Company. All preliminary steps of the grievance

procedure prior to Step 3 will be omitted in such cases.

- 11.03 Such discharge grievances may be settled by confirming the Management's action in dismissing the employee or by reinstating the employee with full compensation for time lost, or by any other arrangement of discipline and compensation which is just and equitable in the opinion of the parties of the Arbitration Board.
- 11.04 When an employee has been dismissed without notice, they shall have the right to interview their Union Representative for a reasonable period of time before leaving the premises.

ARTICLE 12 – GRIEVANCE PROCEDURE

- 12.01 It is the mutual desire of the parties hereto that complaints of employees shall be adjusted as quickly as possible, and it is generally understood that employees have no grievance until they have first given to their immediate supervisor, an opportunity of adjusting their complaint.
- 12.02 If an employee has any complaint or question which they wish to discuss with the Company, they shall take the matter up with their immediate Supervisor and they may be accompanied by their Union Representative if they request such assistance. This complaint must be submitted within ten (10) working days from the incident after the Union or the employee becomes or should have become aware of the alleged violation.
- 12.03 If such complaint or question is not settled to the satisfaction of the employee concerned within three (3) working days, then within three (3) further working days, the following steps of the grievance procedure may be invoked in the order listed below:

Step 1

The complaint shall be submitted in writing and discussed with the immediate Supervisor, who will then

have three (3) working days to submit a written reply.

Step 2

If the grievance remains unresolved, the employee, accompanied by his/her Union Representative (limit three) will, within three (3) working days, take the matter up at a meeting with the Department Manager (or authorized representative) and/or such other members of staff (limit three) which may be required by the Company.

The Department Manager will then have three (3) working days to provide a written decision.

Step 3.

If the grievance is still unresolved, the Grievance Committee (limit 4) shall meet with the Plant Manager (or authorized representative – limit 4) and such other members of staff as required, within five (5) working days of the Step 2 decision.

The National Representative of the Union may attend this meeting.

The Plant Manager (or authorized representative) will then have three (3) working days to provide a decision.

- 12.04 If arbitration is to be invoked, the request for arbitration must be made in writing within fourteen (14) calendar days after the grievance has been dealt with in Step 3.
- 12.05 If required, the time limits indicated in Steps one, two, and three of the grievance procedure, may be extended, by mutual agreement between the Company and Union Representatives.

ARTICLE 13 – DISCIPLINE RECORD

- 13.01 Written disciplinary records will be disregarded after twelve (12) months provided there has been no other written disciplinary measures against the employee from the date of issuance of such written warning. Safety

violations will be disregarded after eighteen (18) months provided there has been no other written disciplinary measures, including safety violations, against the employee from the date of issuance of such written warning. Discipline for absenteeism will be categorized separately. Discipline involving violence or harassment will remain in the employee's file for a maximum of five (5) years.

ARTICLE 14 – ARBITRATION

14.01

- a) Either party may submit the grievance to Grievance Mediation at any time within five (5) days following receipt of the grievance.
- b) Grievance Mediation will commence within twenty-one (21) calendar days of the grievance being submitted to mediation.
- c) The Grievance Mediation is without prejudice to either party.
- d) No matter may be submitted to Grievance Mediation that has not been properly carried through the grievance procedure.
- e) By mutual consent, a matter may be withdrawn from mediation and the grievance will be considered resolved or may go to arbitration.

14.02 If the parties cannot agree to an Arbitrator, then either party shall have the right to request an appointment of an Arbitrator by the Minister of Labour as per Section 48 of the Ontario Labour Relations Act. This appointment shall be consistent with this provision.

14.03 Should either party request that any matter concerning the interpretation or alleged violation of this Agreement be submitted to arbitration, it shall make such request in writing, detailing the matter to be arbitrated and at the

same time nominate an Arbitrator.

- 14.04 The decision of the Arbitrator shall be final and binding on both parties and the employees concerned.
- 14.05 The Arbitrator shall not have the power to alter or change any of the existing provisions of this Collective Agreement or to substitute any new provisions into the Agreement, not to give any decision inconsistent with the terms of this Agreement.
- 14.06 The parties shall equally share the full expense of the Mediation and/or Arbitration.

ARTICLE 15 – LABOUR MANAGEMENT

- 15.01 The Management of the Company and the direction of the working force, including the right to plan, direct and control Company operations, to hire, transfer, or to relieve employees from duty because of lack of work or for other reasons, and the right to introduce new and improved production methods or facilities is vested exclusively in the Company subject to the seniority rules, grievance procedure and other provisions of this Agreement as herein set forth.
- 15.02 If changes in manufacturing or improved production methods are contemplated by the Company, the Union will be notified. The Union agrees not to hinder or prevent the Company from making or proceeding with such improved manufacturing or production methods, including but not limited to the installation of new machinery if necessary. The Union further agrees to operate the new machinery or equipment on both a trial or production basis.
- 15.03 Where any new classifications are created, such classifications shall be subject to commencement of negotiations between the Company and the Union within thirty (30) days following the initial production run for inventory. A supplementary agreement covering such

new classifications shall be executed and shall be retroactive for the hours worked on the job to the date of the initial production run for inventory.

- 15.04 Should the parties fail to agree, such dispute shall be submitted to a representative of the National Union and the Plant Manager. Should both officials fail to reach an agreement, the matter may be submitted to arbitration in the usual manner.

ARTICLE 16 – SENIORITY

- 16.01 New employees shall be considered on probation and shall not be entitled to seniority rights until they have completed ninety (90) days of work with no extensions unless mutually agreed upon. Upon completion of the probationary period, seniority shall be dated from the first day of employment. During an employee's probationary period, they shall be considered as being employed on a trial basis and may be discharged or laid off at the discretion of the Company. Date of hire will be stamped on the employment application by Human Resources. Seniority will be determined alphabetically by the employee's last name.

16.02

- a) Seniority shall be plant-wide, except for the Maintenance Department, and the Company will prepare a seniority list, a copy of which will be available to the Union. If it becomes necessary to lay off employees or in case of promotion, upgrading, or vacancies in the plant, excluding Maintenance employees, (see Article 19) seniority shall be the determining factor unless it is mutually agreed that the senior employee is incapable of filling the position.
- b) When an employee has not been on a job for an extended period of time, and the Company requires the employee to work the job or the employee fills that

job to maintain their seniority rate, that employee shall be re-familiarized on said job for a period of time necessary to ensure that both the procedural and safety requirements of the job can be met.

- c) The exceptions to the above are cases whereby major modifications have been made to existing equipment or new equipment has been installed which would result in an employee requiring extensive retraining. Re-familiarization is restricted to job review, safety refresher and any minor changes to equipment or procedures.
- d) The Company will ensure that all employees within a department will be trained on all jobs within the job rate within 1 year.
- e) The following positions - both bid and pool - will not be subject to the provisions of 16.02(a). Rather, the selection of these positions will be given to the employee with the best skills, ability, education and experience. In the event the Company determines these factors are relatively equal, then seniority will govern. The Company will discuss the minimum qualifications for these positions with the Union. The Company will administer a test to determine whether the employee meets the requirements of the position.
 - Maintenance Planner
 - Warehouse Coordinator (Raw. Finished Goods)
 - QC Tech
 - 5S Coordinator
 - Raw Material Handler/Relief Coordinator
 - Lubrication specialist
 - Roll Specialist
- f) To support employees who wish to be considered for

these bid jobs, the Company will reimburse the cost of education courses proactively undertaken by employees to meet the minimum qualifications. The education courses must be pre-approved and successfully passed prior to the posting as a condition of reimbursement.

- g) When a vacancy exists within the Supply Driver position, it will be offered by seniority to all Forklift Operators who hold a bid or pool position, and the subsequent Forklift vacancy will be posted.

16.03 In case of lay-off or in case of promotions, upgrading or vacancies in the Maintenance Department, the provision of Article 19 shall govern.

16.04

- a) Job Openings shall be posted fourteen (14) days in advance of the permanent filling of any vacancy or newly created job. In the event an eligible employee is absent due to illness, job related injury, vacation, or lay-off for a period not to exceed four (4) weeks at the time of job posting, the employee shall be considered with the other eligible employees and if selected the job will not be permanently filled until the employee returns to work. The schedule and bumping period deadline for the following work week will be set by Thursday at 9:00 a.m. and will not be subject to change unless deemed necessary by the Company. When preparing the schedule the Company agrees to fill positions in order of seniority, subject to the individual's seniority and qualifications.
- b) Extra people called into work a scheduled 40-hour week shall be entitled to any overtime during the week and/or weekend according to seniority and qualifications.
- c) Employees called into work from lay-off with no step-

up procedure involved shall be considered scheduled and will be considered for all overtime according to seniority and qualifications.

16.05 An employee shall lose their seniority rights:

1. If they are discharged and not reinstated under the grievance or arbitration procedure provided by this agreement.
2. If they quit.
3. When they have been laid off continuously for a period of six (6) months. For those employees with two (2) years or more service, for a period of thirty-six (36) months.
4. a) If, within three (3) days after receipt by registered mail of notice to return to work following a lay-off, they fail either to:
 - i. return to work or;
 - ii. notify the Company of their intention, to return to work and do not return within eight (8) days after receipt of notice to return.
- b) In any case where notification by registered letter has been returned undelivered, inquiry shall be made to the Union in an effort to locate the employee. If an employee cannot be located by these two attempts, then the employee shall be considered as having given up any seniority rights, even though six (6) months referred to in sub-paragraph 3 above has not elapsed.
- c) Extenuating circumstances shall be taken into consideration by the Company, and extended time limits may be granted.
5. If an employee is absent for three consecutive days without proper notification to the Company. Each case will be reviewed on its own merits.

- 16.06 Employees who may be rehired by the Company after any of the above breaks in continuous service will be rehired as new employees.
- 16.07 If an employee becomes physically unable to do his or her job, the Company will place the employee in an existing job within his or her capabilities, in accordance with the Ontario Human Rights legislation and in consultation with the Accommodation Committee.
- 16.08 Students hired for the purpose of Vacation Relief shall not be entitled to the provisions of this Article.
- 16.09 The Company will be entitled to rely upon the last address and telephone numbers of an employee as shown in the Company records. Employees shall notify the Company promptly of any change of address or telephone numbers.
- 16.10 Super Seniority
In cases of lay-off of production personnel (excluding skilled trades), the Union President will be the last Bargaining Unit employee to be laid off and in all cases of recall of production employees, the Union President will be the first employee called back.

ARTICLE 17 – PROCESSING, SHIPPING and PACKAGING DEPARTMENTS

- 17.01 Employees may hold one bid or one pool job (not both). The Company will ensure that all training associated with any bid or pool job will be completed within six months. Any unusual circumstances will be discussed between the parties should they arise. Job shadowing will be considered the first week of training for positions which require an extended period i.e. four weeks or greater. No job shadowing is required for positions which require less than four weeks of training, unless the employee is newly-hired into the Processing Department.

- 17.02 Any employee bidding to another job shall remain on said job for at least one (1) year, except to bid on a newly created position or Bosch Packaging vacancy or if they bid into a Maintenance Planner, Warehouse Coordinator, Stockroom Clerk, QC Tech or position in which case they shall remain in said position for at least one (1) year. A newly created position is defined as a job not previously performed by bargaining unit employees. The Company will offer job preference three (3) times with the resulting opening not subject to the policy.
- 17.03 Employees currently holding a bid job or pool job who wish not to retain a bid or pool job will be returned to either the Processing or Packaging Department. These Employees can transfer from one department to another only if openings occur.
- 17.04 In the event of an employee failing to prove satisfactory (with proper documentation) on the requested position, they shall return to either the Processing or Packaging Department, according to seniority.
- 17.05 In the event of a cutback in production requiring downsizing of the work force all holders of the bid job (Sanitarian) will be protected for a period of one (1) month and will not be bumped out of their own bid job because of seniority after which time seniority and qualifications will be the determining factor.
- 17.06 Step-ups and Step-backs
An employee with a minimum of 15 years of service who refuses a step-up will be frozen and will forfeit the right to progress to any jobs with a pay rate higher than the rate directly below that of the job that they refused in that Department. They will remain frozen for the life of the collective agreement at which time they must notify the Company in writing should they wish to be unfrozen.

The exception to the above will be a lay-off situation whereby a frozen employee (frozen as of January 10, 2020) may exercise their seniority to displace a junior employee in a higher pay rate providing they currently have the qualifications to perform the job.

If it becomes necessary to force a frozen employee to step- up it will be done by inverse order of seniority and qualification on a temporary basis.

17.07

- a) Any employee who accepts a step-up over a senior employee retains job preference in all subsequent step- ups.
- b) On a cutback, they cannot displace the individual whom they replaced in job preference, but must step down to the next senior job.

17.08 In the event of a cutback in production, the employee in question will be allowed to remain on their job, if he/she qualifies by overall seniority. If he/she is displaced by a senior employee for less than a shift, the affected employee may displace the most junior employee in his/her department, providing they can perform the job. This affected employee may displace the junior employee in the plant on his/her shift, providing they can perform the job. In the unlikely event the senior employee is incapable of performing the junior person's job, work will be made available for this employee except in cases whereby the employee is not qualified due to freezing out of this position in the past.

Any employee exercising their options in the above will maintain the higher of the two pay rates.

Downsizing the labour force for one shift or more will be handled according to seniority, however, to administer this, the Company will have the remainder of the shift to

the next available shift of the following day to allow employees to exercise seniority rights to either displace the most junior employee on another shift or to choose to take a lay-off.

The Company will make every reasonable effort to contact the employees for the next shift in regards to downsizing the labour force. The premium as defined in Articles 17.10 and 28.14 does not apply in this shift change. (Re-familiarization provisions in 16.02 shall apply.)

- 17.09 The Company maintains the right to move people from one job to another within the shift to meet changing production needs, unless the person hasn't been on that job in 1 year, if employees are assigned to jobs contrary to their seniority, they will be paid the highest rate of the two jobs involved.

Temporary vacancies (one week or less) in the Processing Department will be filled on the basis of the step-up procedure by the employees on the affected shift. However, if there are insufficient qualified employees after the step-up procedure and including recall from lay-off, and if it is necessary to fill the remaining vacancy, it will be filled by overtime for the first day and in a manner consistent with the other terms of this Collective Agreement thereafter.

In the unlikely event it becomes necessary to reschedule an employee from one shift to another once the employee has already commenced his/her workweek, the employee will receive time and one-half (1-½) for their first new shift providing they haven't received twenty-four (24) hours notice from the commencement of their new shift. These rulings shall be in effect to all employees, the only deviation to be in cases where there are compassionate reasons, those to be adjusted by a committee of the Company and Union.

17.10 Hiring New People

New unskilled positions will be hired into the Packaging Department or Processing Department depending on production demands.

17.11 The Company is responsible for training individuals in Processing, Shipping and Packaging to fill jobs within their own department by seniority. Operators will be responsible for but not limited to changeovers, equipment sanitation, minor non-skilled adjustments as well as operator PM's. Any unusual circumstances will be discussed between the parties should they arise.

ARTICLE 18 - POSTING AND FILLING OF POSITIONS - BOSCH

18.01 Job openings in the Bosch shall be posted for six (6) working days in advance of the permanent filling of any vacancy or newly created job.

18.02 The determining factors in selecting the successful applicants will be based on seniority and successfully obtaining a passing grade on the entrance level aptitude test. The test result will be made available to the Union upon request.

18.03 Upon completion of the Training Program, employees shall not bid on any posted job for at least, two (2) years, unless a newly created position occurs.

ARTICLE 19 – POSTING AND FILLING OF POSTIONS – MAINTENANCE

19.01 The Company will select and control all personnel in this Department subject to qualifications and seniority.

19.02 Employees of other departments will be considered for this Department subject to necessary qualifications and seniority, only when an opening is available.

Job openings shall be posted six (6) days in advance of

the permanent filling of any vacancy or newly created job.

19.03 In cases of cutback or lay-offs, those presently engaged in this Department could step down in classification within the Department if qualified to do so, or could transfer into a Processing/Shipping/ Packaging Department in accordance with their plant seniority and necessary qualifications.

19.04 During a twelve (12) month period, an employee who transfers to Maintenance will continue to accumulate seniority in Processing/Shipping/Packaging and if they wish to return to Processing/Shipping/Packaging during the twelve (12) month period, the employee may use their seniority to displace a more junior employee providing they can perform the work available. After the twelve (12) month period the employee will not continue to accumulate seniority in Processing/Shipping/Packaging and may not use their seniority to displace a more junior employee.

19.05 Skilled trades Overtime Equalization

Purpose and Intent: To equalize the overtime opportunities to the defined groups specified in the Collective agreement as described in Schedule "A" of the collective agreement Maintenance Skilled Trades.

General Rules

1. Overtime Canvassing

a) Scheduled production overtime shift requirements may be posted by the Company with a separate list for each shift. Such posting shall take place no later than 7 a.m. Wednesday. Employees shall sign up for these overtime opportunities by 11 a.m. on Thursday.

b) Weekend maintenance opportunities shall be

posted by 12 p.m. Thursday. Employees shall sign up for such overtime opportunities by 11 a.m. on Friday.

- c) An employee absent for any reason shall call or text into the maintenance supervisor or his designate if they wish to have their name added to such lists.

2. Scheduled Overtime Procedure

- a) Scheduled overtime shall be offered to the senior scheduled person(s) available in the following order: same shift, same job, same rate. If the overtime position is not filled it shall be offered by seniority to the scheduled person(s) on the following shift, same job, same rate, and, if not filled, by seniority to the scheduled person(s) on the previous shift, same job, same rate.

3. Unscheduled Overtime Procedure

- a) If unscheduled vacancies occur after the start of a new week, the four (4) hours shall be covered by the preceding shift and the second four (4) hours by the following shift.
- b) When the schedule is created, if it is known that there will be a vacancy for less than three (3) shifts, it shall be treated as an unscheduled vacancy.
- c) When the schedule is created, if it is known that there shall be a vacancy for three (3) or more shifts, it shall be treated as a Schedule Fill-in.

4. Schedule Fill-ins

- a) The maintenance supervisor or his designate shall maintain a list to track schedule fill-ins by employee. The list will reset to 0 for all employees on January 1st.

- b) When an off-shift vacancy occurs, and where there are no volunteers, the person with the lowest point total who is on days shall be scheduled to fill-in for the vacancy. If two or more employees have the same number of points, the lowest seniority employee shall be scheduled to cover the fill-in.
 - c) Employees who are required to complete a fill-in shall receive 1 point on the tracking list.
- 5. If a task carries over and overtime is required on the next shift to complete the task, then the person(s) who is performing the task shall be asked first.
 - 6. The Company and the Union will meet as required to discuss issues and/or concerns.

19.06 In the unlikely event it becomes necessary to reschedule an employee from one shift to another once the employee has already commenced their workweek, the employee will receive time and one-half (1½) rate for their first new shift providing that they haven't received twenty-four (24) hours notice from the commencement of their new shift.

If an employee's scheduled shift is changed and the employee is not notified of such change at least forty-eight (48) hours prior to the start of their workweek, they shall be paid time and one-half (1½) rate for the first eight (8) hours which follows such change of schedule.

19.07 Maintenance and Repair Department Capital Projects
When a team is required for a capital project, the following process will apply:

- a) The content of the project will be posted for five (5) days. The posting will include a brief description of the project, the Project Manager's name and expectations, and the required skills of the employees.

- b) An interview process will occur, where the expectations of the candidate will be clarified and the opportunity of asking for more information will be available.
- c) It is understood, if a person that has been selected does not meet the expectations, that person may be removed from the project.
- d) Any overtime generated from the project will be assigned to the project team members first.

19.08 Unifor Skilled Trades Council dues of one-half (0.5) hour dues per year as per the Unifor Constitution, be deducted from every skilled trades member covered by the Collective Agreement and be forwarded to the National Skilled Trades Department in January of each year.

19.09

1. Once ticketed, a Five (5) year commitment to work for the Company as a Journeyman will be required in return for the tuition investment made by the Company. Otherwise, all monies paid by the Company, except wages, will be owed and payable to the Company, within thirty days of exit.
2. Apprentices will only be offered overtime opportunities when all of Trade groups as identified in Schedule "A" of the Collective Agreement, Maintenance skilled Trades have been exhausted.

ARTICLE 20 – LAY-OFFS

20.01 Whenever it becomes necessary to lay-off employees, they shall be laid off in turn, according to seniority, as agreed upon, provided however, that the Company shall always have the qualified personnel to maintain production. When recalling employees to work after lay-off, they shall be recalled in the inverse order to that in which they were laid off.

ARTICLE 21 – LEAVE OF ABSENCE

- 21.01 Requests for leave of absence by an employee should be submitted to the Company in writing, at least seven (7) days in advance with the understanding that this may not always be practicable. Wherever good and sufficient reasons exist, the Company may grant a leave of absence which will not be unreasonably denied, of not more than thirty (30) days. As part of any LOA time granted, existing vacation days must be utilized first, to cover time off approved, unless previously scheduled. The Company will advise the Union when a Leave of Absence has been granted.
- 21.02 Such leave of absence may be extended for an additional period of not more than thirty (30) days under the same conditions.
- 21.03 Any employee engaging in other employment during a leave of absence, or extension thereof, shall be subject to immediate dismissal.
- 21.04 Designated representatives of the Union may apply for a leave of absence to attend union business. The Union will make every effort to make a request in writing at least five working days prior to the commencement of the leave. For an approved leave greater than 30 days in length, the Union will reimburse the Company the cost of maintaining benefit coverage during the leave period.
- 21.05 Any employee elected to Public Office will, upon request in writing, be granted a leave of absence without pay, not to exceed thirty (30) calendar months without a break in continuity of Company service. An extension of such leave will be granted by mutual agreement of the Company and the Union prior to termination of the original leave. For an approved leave greater than 30 days in length, the employee will reimburse the Company the cost of maintaining benefit coverage during the leave period.

- 21.06 At the request of the employee, the employer will grant a special leave of absence not to exceed twenty-six (26) weeks for the terminal illness of the employee's spouse, child, parent or parent-in-law, or other dependent family members. Employees who take such special leave may be required to provide satisfactory evidence of the purpose of such leave.
- 21.07 Employees shall accumulate seniority during periods of leave of absence. Such employees shall, on their return at the expiration of any leave of absence granted to them, be reinstated to their previous or similar work in line with their seniority.

ARTICLE 22 – MEDICAL/DENTAL/INSURANCE PLAN

- 22.01 The Post Foods Canada Inc. Health Care Plan is offered to full-time permanent Unionized hourly Niagara Falls employees. Employees and their eligible dependents are covered under the plan immediately following the probationary period with Post Foods Canada Inc.
- 22.02 All regular full-time employees will be covered for expenses incurred while on lay-off for a maximum period of six (6) consecutive months.
- 22.03 Coverages of each of the plans will be set forth in booklets available for each employee.
- 22.04 The Company agrees to notify the Union sixty (60) days prior to any change in benefit carriers.

ARTICLE 23 – BEREAVEMENT LEAVE

- 23.01 In the event of death in an employee's immediate family for sister or brother, mother-in-law or father-in-law, brother or sister-in-law, grandparents, or grandchildren, the employee shall be entitled to be absent from work for a period up to but not more than three (3) regular working days when such absence is necessary to make arrangements for and/or attend the funeral and to grieve.

Bereavement leave covers the employee's absence on the day of the funeral. The other two (2) days must be taken within five (5) days before or after the day of the funeral.

In the event of death in an employee's immediate family of spouse, children, parents or step parents of the employee, the employee shall be entitled to be absent from work for a period up to but not more than five (5) regular working days when such absence is necessary to make arrangements for and/or attend the funeral and to grieve. Bereavement leave covers the employee's absence on the day of the funeral. The other four (4) days must be taken within seven (7) days before or after the day of the funeral.

An employee will be entitled to be absent from work for one (1) working day, on the day of the funeral, for the death of grandparents-in-law, aunts or uncles.

If the funeral takes place on an employee's scheduled day off the employee must take that day of bereavement on the scheduled day of work immediately before or following the funeral.

23.02 During such absence, the employee shall be compensated at his or her straight time hourly classification rate for such regular working time lost.

23.03 Such absentee compensation shall not include pay for lost overtime. It shall include paid holiday pay/ or shift premium. An employee on vacation when bereavement occurs shall be entitled to take any lost vacation days up to a maximum of three (3) or five (5) regular consecutive working days at a later date as mutually agreed upon between the Company and the employee.

ARTICLE 24 – UNIFORMS

24.01 The Company will furnish and pay for all necessary work-uniforms worn by its employees. Uniforms will be

laundered at the expense of the Company and shall remain Company property.

ARTICLE 25 – SHIFT PREMIUM

- 25.01 It is agreed between the Company and the Union that a premium of eighty (\$0.80) per hour shall be added to the regular hourly rate of all employees when they work on a scheduled second shift and one dollar (\$1.00) per hour on the scheduled third shift.
- 25.02 The above premium rates do not apply to the first (day) shift.
- 25.03 The shift premium shall be computed without regard to overtime pay provisions.

ARTICLE 26 – PREMIUM FOR SUNDAY WORK

- 26.01 During the life of the contract, the Company agrees to pay employees who are scheduled to work and do work, two dollars (\$2.00) per hour in addition to their straight time hourly rate for each hour worked on Sunday and the day observed by the Company and Union as Paid Holidays as per Article 31.
- 26.02 It is understood that this additional rate of two dollars (\$2.00) shall only be paid for hours worked between 12:01 a.m. and 11:59 p.m. on Sunday and Paid Holidays.
- 26.03 The above premium is to be calculated without regard to overtime provisions. In other words, the premium is paid for all hours worked but not to be calculated with overtime premium.

ARTICLE 27 – REPORTING PAY AND CALL BACK

27.01 Reporting Pay

Employees called for work by the Company and who report for work are to receive four (4) hours pay, provided, however, that at the option of the Company, any or all such employees who are called for and report

for work, accept work in classifications other than those for which they may have been called, if in the judgment of the Company, such other work is necessary.

27.02 Call Back Pay

Any employee called to work after completing their previous day and prior to commencing their current or next day shall receive pay as per Schedule "A" but not less than (3) hours pay at the rate of time and one-half (1-½) the straight time hourly rate. If an employee receives a call back but they are not able to report to work for the time specified, the individual making the call can move down the list of employees in order of seniority to try and find someone to come in for the required time.

1. If an employee is called to work within a two (2) hour period prior to their assigned starting time, they shall receive the above compensation. However, if the initial emergency is completed prior to their assigned starting time, they may be assigned other work.
2. If any employee reports for work prior to their assigned starting time by their own accord and are requested to perform work during this prior period, they shall receive time and one-half (1½) rates for any hours worked over eight (8) hours on that day.
3. If an employee is called to work prior to two (2) hours before their assigned starting time, they shall receive compensation at time and one-half (1½) rates for hours worked with a minimum guarantee of three (3) hours at the rate of time and one-half (1½) the straight time hourly rate.
4. The maximum payment for an employee's assigned daily eight (8) hours will be at straight time rates.
5. The maximum rate that can be paid for any time worked is time and one-half (1½) the applicable straight time hourly rate.

ARTICLE 28 – HOURS OF WORK AND WORKING CONDITIONS AND OVERTIME

- 28.01 Forty (40) hours, consisting of five (5) consecutive eight (8) hour days shall constitute a workweek.
- 28.02 The normal workday shall be one (1) of eight (8) consecutive hours.
- 28.03 A day worker is an employee who is assigned to a job that is regularly scheduled on days between the hours of 6:00 a.m. to 4:00 p.m., Monday to Friday.
- 28.04 A shift worker is an employee who is assigned to a job which is regularly scheduled in any of the following categories:
- a) A job on regularly rotating shifts (day, afternoon and night).
 - b) A job regularly rotating between any two shifts.
 - c) A job on either the afternoon or night shifts.
 - d) A job on days which is scheduled for any days of the calendar work week which includes Saturday and/or Sunday.
 - e) The Company will continue the current rotation practice within the weekly schedule, rotating employees from job to job, shift to shift, within the employees department, e.g., shipping, processing, packaging.
 - f) The Company will maintain the current shift trading practices with the existing trade policy.
- 28.05 Employees will receive a one half (1/2) hour paid lunch period. Employees who leave the plant during the lunch period must punch out when they leave and punch back in when they return. Employees will not be paid for the time that they are not on the property.
- 28.06 Any employee working ten (10) or more consecutive

unscheduled hours, in any one shift, shall be granted a meal allowance of twelve fifty (\$12.50) The meal allowance will be paid via normal payroll process. Unscheduled means employees were asked for the OT after the end of their previous shift.

- 28.07 Employees will receive two (2) fifteen (15) minute paid reliefs.
- 28.08 All time worked over eight (8) hours in any one (1) shift shall be considered as overtime and shall be paid at the rate of time and one-half ($1\frac{1}{2}$) the regular straight time hourly rate.
- 28.09 All time worked over forty (40) hours in any one (1) work week shall be considered as overtime and shall be paid at the rate of time and one-half ($1\frac{1}{2}$) the regular straight time hourly rate.
- 28.10 Overtime is to be calculated on either the daily basis (28.08) above or weekly basis (28.09) above, as may be applicable, but not both.
- 28.11 Any individual employee whose work week is changed on a step-up or step-down in production or shift schedule will not be entitled to overtime under Sections 28.09 and 28.12, should his/her new shift start on the sixth (6th) or seventh (7th) day of his previous scheduled shift.
- 28.12 Time and one-half ($1\frac{1}{2}$) the straight time hourly rate shall be paid for all work performed on the sixth (6th) day, providing the employee has worked their scheduled 40 hour work week other than excused absences and two (2) times the straight time hourly rate shall be paid for all work performed on the seventh (7th) day in any work week. The sixth (6th) and seventh (7th) days are defined as the employee's scheduled days off.
- 28.13 Employees will be paid and scheduled weekly. Pay on each Thursday will include all hours worked between 12.00 a.m. on the Sunday up to 11:59 p.m. on the

Saturday prior to the pay day. This shall have no impact on the rate to be paid for hours worked which shall continue to be calculated in accordance with the Collective Agreement.

- 28.14 If an employee's scheduled shift is changed and the employee is not notified of such change at least forty-eight (48) hours prior to the start of his/her workweek, he/she shall be paid time and one-half (1½) rate for the first eight (8) hours which follows such change of schedule.

28.15 SCHEDULED OVERTIME PROCEDURE

(Processing/Shipping/High Tech Packaging and Packaging) Overtime is all work scheduled over and above normally scheduled working hours, according to Article 28.01 and 28.02.

- a) Scheduled overtime will be filled the same as unscheduled overtime with the exception of when trades are made for less than one (1) week, in this case, scheduled overtime goes to the person scheduled.
- b) Vacancies on scheduled overtime will be filled by the next senior person eligible as per schedule.
- c) If an employee does not accept or sign up for a scheduled overtime opportunity it will be acknowledged that the person has been canvassed and they will not be eligible again until all other employees have declined.
- d) When a temporary vacancy occurs due to absenteeism on scheduled overtime, Article 28.16 B4 will apply unless sixteen hours (16) advance notice is given.

28.16 UNSCHEDULED OVERTIME PROCEDURE

Unscheduled overtime is all work performed but not

scheduled, over and above normally scheduled working hours due to a vacancy on a specific job or to satisfy unscheduled packaging or production requirements, according to Article 28.01 and 28.02.

Procedural Steps

- a)
 - 1. Offer to the person scheduled on the job (this includes bid and non bid positions)
 - 2. Offer to the senior scheduled person available on the same rate, same shift and same department including department trainers.
 - 3. Offer to the senior scheduled qualified person available, on the same shift and same department.
 - 4. Offer to the senior scheduled qualified person available, any department, same shift, including those on bid and pool positions.
 - 5. Offer to the senior scheduled qualified person, any shift, same rate and same department.
 - 6. Offer to the senior qualified person available, any department except Maintenance and Repair.
 - 7. Overtime person goes to opening.
- b)
 - 1. In cases where a person is stepped-up or down during the week, the person scheduled on the job will be entitled to any overtime.
 - 2. If a person scheduled on the job required for overtime is absent, it becomes an open shift, we then start with a) 2.
 - 3. a) When trades are made for a full week, overtime goes to the person who works the job.
b) When trades are made for less than one (1) week, scheduled overtime goes to the person scheduled.

4. When a vacancy occurs, the first four (4) hours will be filled by the preceding shift and the second four (4) hours will be filled by the following shift.

28.17 All employees will be enrolled in Electronic Funds Transfer (EFT)

ARTICLE 29 – JURY DUTY

29.01 The Company agrees to pay up to eight (8) hours at the straight time hourly rates, depending upon the daily working hours for the department of the employee involved, for each day an employee is required to serve and does serve on any jury, or is subpoenaed as a witness, provided the employee would have been scheduled to work on the day or days actually served on the jury. The provisions of Article 28.01 apply.

29.02 The employee, however, will be required to turn into the Company, the jury duty fee (any monies received to compensate for lost wages), in order to receive the compensation provided.

ARTICLE 30 – VACATIONS

30.01 Employees will be required to submit their vacation requests by the second Friday in January. The Company will complete the schedule of vacations by the second Friday in February. After the vacation schedule has been completed, any additional vacation time may be approved. If the maximum number of employees permitted to take vacation in a week has not been filled, the remainder will be filled on a first come first served basis. If the maximum number of employees permitted to take vacation in a week has been filled and the Company offers more vacation for that week, the remainder will be filled based on seniority. Employees that have not taken their vacation by the end of the calendar year may be allowed to schedule one week of vacation in the following January.

30.02 Schedule:

Two (2) weeks after 1 (one) year of service

The Company will accommodate two (2) of the vacation weeks in the prime-time vacation period which includes – from the third Monday in May, June, July and August

Three (3) weeks after 5 (five) years of service

Four (4) weeks after 10 years of service

Five (5) weeks after 18 years of service

Six (6) weeks after 25 years of service

All new hires, as of January 10, 2020, will get six (6) weeks' vacation after twenty-eight (28) years

30.03 Any employee hired after August 31st and before December 31st shall be entitled to receive a vacation in the regular vacation period of the following year; however, the vacation pay shall not be paid to the employee until after the anniversary date of the employee's employment.

30.04 Pay for the vacation shall be on the basis of four percent (4%), six percent (6%), eight percent (8%), ten percent (10%) or twelve percent (12%), of the earnings for the previous calendar year or the rate for the classification at which he or she is employed at the time of vacation at the normal hours per week, whichever is greater.

30.05 In the event of an employee leaving the service of the Company, vacation payment, shall be paid to such employees in accordance with the provisions outlined above, namely 4%, 6%, 8%, 10% or 12%.

30.06 NOTE: Earnings represent the total received in hourly rates and shift premium.

30.07 If a plant shutdown is planned, employees not scheduled to work will be required to take a portion of their vacation during the shutdown period in accordance with the

following schedule.

Number of Weeks of Vacation Eligibility	Vacation to be Taken During Shutdown
1 week	0
2-3 weeks	1
More than 3 weeks	2

If a one-week summer shutdown is planned, employees with two weeks or less vacation will not be forced to take vacation during this time. If a two-week summer shutdown is planned, employees with two weeks' vacation must take one week's vacation during the summer shutdown. Certain classifications may be required to work during all or part of a summer shutdown. The Company will not grant preferred layoffs during a plant shutdown. In the event of a change in schedule during the summer vacation shutdown, employees on vacation are still eligible for work opportunities.

- 30.08 The Company and the Union agree that Single Day Vacation benefits the health and mental well-being of the employees. The Company and Union also agree that single day vacation has the potential to create operational issues if not properly managed.
- 30.09 To this end, the Company and the Union agree that employees who are entitled to three (3) or more weeks of vacation will have the right to take up to five (5) days of their vacation on a day at a time basis. Employee requests for a single day of vacation must be submitted to the supervisor at least five (5) days prior to the day requested by the employee. Requests for a single day of vacation will be considered on a first come, first served basis, i.e. in order of request, based on the operational needs of the business and weekly vacation requests. It is understood and agreed that the decision

on whether to approve or not approve a single day vacation request is vested solely in the Company.

30.10 Employees will be allowed up to four (4) days from their Single Day Vacation entitlement, to be taken as sick days. These days are not to be used against the attendance policy.

30.11 Preferred Layoffs

The Company will not grant anyone a preferred layoff until all their vacation is used up or scheduled.

ARTICLE 31 – HOLIDAYS

31.01 The following days shall be observed as holidays:

New Year's Day
Thanksgiving Day
Good Friday
Christmas Day
Canada Day
Victoria Day
Civic Holiday
Boxing Day
Labour Day
Day after New Year's

In addition to the Paid Days listed above, the Company will grant three (3) additional days. These days will be mutually decided upon by the Company and the Union by March 1st of each year, and the Company will notify the employees. If both parties fail to agree by the above date, the Company will have the final decision on when the holidays will take place.

The maximum number that can be paid is thirteen (13) paid days in a calendar year.

31.02 The Company agrees to pay all the employees covered by this Agreement, one (1) full day's pay for each of the above- listed holidays on which they do not work or to

such of the employees who work on these holidays, two and one-half (2½) full day's pay, subject to the following conditions:

- a) Probationary employees will be paid based on their average regular wages earned in the four (4) weeks preceding the holiday.
- b) The employee must have worked both the employee's last scheduled workday prior to and first scheduled workday after each specified holiday unless the employee's absence is excused by supervision. If a statutory holiday falls on a Friday, those employees will be paid for the statutory holiday for that pay schedule. In the event the employee does not work their first scheduled day after recall, without reasonable cause, the statutory holiday will be deducted from the employee's pay.
- c) During a holiday week any employee who is hired after that holiday, or leaves the service of the Company prior to that Holiday, shall not receive pay for the holiday.

- 31.03 All production work on any other holiday not listed above shall be at straight time.
- 31.04 Any work above eight (8) hours on any of the holidays specified above shall be paid for at two and one-half (2½) times the straight time classification rate.
- 31.05 Any employee working in a shift which carried over into a holiday, shall be paid the classified straight time rate for the shift. Overtime rate for such shift will be paid at the rate of time and one-half (1½) the classified straight time rate.
- 31.06 Cookers shall observe the day preceding a paid holiday as the holiday.
- 31.07 Any employee taking their paid vacation in the week in which any of the above-listed holidays fall, shall receive

an extra eight (8) hours pay for that week.

- 31.08 In weeks in which a paid holiday falls everyone, except Cookers and Sanitarian, shall be scheduled for a workweek of Monday to Friday.
- 31.09 If a holiday falls on a Saturday, it will be recognized on the preceding Friday.
- 31.10 If a holiday falls on a Sunday, it will be recognized on the following Monday.
- 31.11 In cases where successive holidays fall on a Sunday and Monday, they will be recognized on the Monday and Tuesday.
- 31.12 In cases where successive holidays fall on a Friday and Saturday, they will be recognized as a Thursday and Friday.

ARTICLE 32 – SAVINGS CLAUSE

- 32.01 The parties agree that should any article or part of this Agreement be declared by an appropriate authority to be unlawful, or unenforceable, said Article or part shall not affect the validity and enforceability of any other article or part of this Agreement.

ARTICLE 33 – SEVERANCE PAY/CLOSURE AGREEMENT

- 33.01 The Closure Agreement referred to in this article was negotiated in good faith between the Company and the Union to provide as much protection and help as possible to employees in the event of a full or partial closure.

In the event of a full or partial closure of all or part of the business, the Company will notify the Union as far in advance as possible. Such notice shall be in writing and indicate the reason for the action.

- 33.02 In the case of partial or full plant closure, the Company shall supply the Union with a current seniority list immediately.

- 33.03 The Company agrees to meet with the Union to discuss the contemplated shutdown with a view to providing a solution to the problem, or jobs for the employees involved. To this end, the Company and the Union will put into place a Human Resources Adjustment Committee, comprised of two (2) Management and two (2) Union Executive representatives, to provide out-placement services for employees. Such services would include, but are not limited to, resume writing, counseling and job search assistance. The full scope of the Committee's responsibilities will be defined by the Committee members. This Committee will be funded by the Company and remain in place for twelve (12) months after the closure/partial closure date.
- 33.04 An employee, excluding an employee on probation, who is permanently laid-off or terminated due to such causes as transfer or discontinuance of the manufacture of a product, introduction of new equipment or processes, closing of the plant or part of the plant, or other cases which, insofar as the Company can determine, permanently reduce the work force, shall be entitled to benefits under the Severance Allowance/Closure Agreement in accordance with the following provisions:
1. The Company will advise the Union as soon as possible in advance if a permanent lay-off or termination with Severance Allowance, as provided in this Article, is to take place.
 2. Effective January 8, 2002, an employee who is eligible for Severance Allowance shall be paid an amount equal to the employee's regular wages for ten (10) days of non- overtime work multiplied by the sum of:
 - a) to an employee with less than three (3) years seniority;
 - b) to an employee who is temporarily laid-off due to the fluctuation of volume of business;

3. An employee who is permanently laid-off or terminated may elect to remain on the plant seniority list for possible recall. In such cases, the Company will pay the Severance Allowance payment to the Director of the Employment Standards Branch in trust for a maximum of twenty-four (24) months, during which time the employee may request payment with a complete break in service.
4. Severance Allowance shall not be paid:
 - a) the number of the employee's completed years of employment; and
 - b) the number of the employee's completed months of employment divided by 12, but shall not exceed fifty- two (52) weeks regular wages for a regular non- overtime workweek.
 - c) to an employee who is discharged for just cause;
 - d) to an employee who voluntarily resigns from the Company's employ;
 - e) to an employee who retires from the Company's employ;
 - f) In the event of closing the plant or part of the plant due to acts of nature or in times of public peril, war, disaster or any other reason of similar nature;
 - g) the number of weeks of Severance Allowance will not exceed the number of weeks remaining to an employee's normal retirement date.

ARTICLE 34 – HEALTH AND SAFETY

34.01 It is the desire of the Company and the Union to maintain high standards of safety in order to eliminate industrial accidents and illnesses.

It is agreed that the current version of the Ontario Occupational Health and Safety Act hereafter referred to

as the Health and Safety Act is incorporated into and forms part of this agreement.

- 34.02 Accordingly, there is hereby established a Safety Committee of six (6) Union members who shall be elected by membership every three (3) years.
- 34.03 It shall be the duty of the Safety Committee, at regular intervals, to make or cause to be made, inspections of the plant and to report the existence of any condition, which in its opinion, shall be hazardous to the employee or employees. The Safety Committee shall meet at regular intervals and shall make recommendations respecting conditions, which in its opinion, require correction.
- 34.04 All employees must wear PPE as deemed necessary by the Company. And the company will cover/replace such PPE as needed, at 100%.

ARTICLE 35 – SAFETY SHOES

- 35.01 The Company agrees to cover a maximum allowance of one hundred fifty dollars (\$150.00) per calendar year to employees, with seniority, for the purchase of safety shoes, including laces and insoles to be worn at work by all employees. The Company will set up a direct bill account with two safety shoe trucks and one store which will allow the employee to produce identification and sign for their shoes. Employees who purchase safety shoes elsewhere will require a receipt in order to be reimbursed by the Company.
- 35.02 If shoes are not purchased in any given calendar year, the allowance may be carried over into the following year. The maximum allowance of two (2) years should be used in its entirety in the second year with the allowance reverting to the amount specified in 35.01.
- 35.03 The employees will be required to submit original receipts or to purchase same through the Company, to

be entitled to said payment.

ARTICLE 36 – TOOL ALLOWANCE

- 36.01 The Company will cover a Tool Allowance of four hundred and dollars (\$400.00) each calendar year for the purchase of tools needed on the job. (Packaging Mechanic, Machinist and Maintenance Repair, Electrician, Roll Mechanic, Utility Mechanic, Lubrication Specialist, and Power Plant Technician). Eligible employees will require an original receipt to be reimbursed by the Company. The tool allowance cannot be used within six (6) months prior to leaving the Company or within six (6) months of an employee's hire date.
- 36.02 If tools are not purchased in any given calendar year, the allowance may be carried over into the following year. The maximum allowance of two (2) years should be used in its entirety in the second year with the allowance reverting to the amount specified in 36.01.
- 36.03 The company agrees to continue its current practice of paying the licensing fees for skilled trades upon submission of an appropriate receipt.


ARTICLE 37 – PERIOD OF AGREEMENT

- 37.01 This Agreement shall be in force and effect from January 11, 2023 to and including January 10, 2026 and thereafter until a new agreement has been consummated and signed, or until this Agreement, after the above expiration date, has upon thirty (30) days notice been canceled by the Company or by the Union provided, however, that either the Union or the Company can submit changes or modifications which they desire, within sixty (60) days prior to January 10, 2026. Any changes will be retroactive to January 10, 2023, unless otherwise agreed upon in the Memorandum of Settlement.

3. Students are entitled to daily man on the job overtime provided all full-time employees on shift are first asked.

Skilled Trades Apprenticeships

The Company agrees to follow the Apprenticeship Curriculum Standards as set out by the Ontario College of Trades.

All employees with 10 years of seniority or more will automatically go to the pay-rate of 2080 hours and will stay there until all hours are completed.

The Company will pay an employee covered by the Apprenticeship Program in the following manner:

Start	60 % of the rate
1,040 hours	75 % of the rate
2,080 hours	80 % of the rate
4,160 hours	85 % of the rate
6,240 hours	90 % of the rate

Completion – Journeyperson's rate

1. All rates to be effective the first of the week following completion of the required service.
2. Upon completion of the program and reclassification to a Journey person, the employee will be credited with department seniority from the original date of hire into the maintenance department.
3. To recognize the incremental expenses for incidentals such as parking, books, travel, etc. for apprentices to attend this program, the Company will reimburse each apprentice with a lump sum payment of \$500 after the successful completion of each eight-week block of study.
4. Apprentices will not be paid the rate until they get their government issued ticket and sign off on all the required competencies. If an apprentice does not pass the required test within two years of completing the schooling and hours, they will be placed back into the department from which they came (without loss of seniority).

PREAMBLE

Along with provincial hospital and medical plans, the Post Foods Canada Inc. Health Care Plan provides you with financial security against the high cost of health care. The Post Foods Canada Inc. Health Care plan will not provide coverage for any gaps created by changes in either the provincial or federal government plans.

Appendix “A” is intended as a plan summary. In the event of any discrepancy between the official document and this summary, the official document will prevail.

If you require further information concerning any aspect of your Health Care Plan, please contact your local Human Resources Department.

An overview of the benefit plans available are given in this Appendix as an indication of the coverage provided. Booklets on all plans provided by the Company for its employees give full details of their purpose, coverage and the limits applicable. These booklets should be referred to for clarification of eligibility, coverage and limits.

The definition of eligible dependents for the Post Foods Canada Inc. Benefit Plans are:

Eligible dependents include your spouse and your dependent children.

Spouse is defined as your legal or common-law spouse. “Common-law spouse” means a person who cohabits with another person in a conjugal relationship, for a period of 12 months. Same sex partners are included in this definition.

Dependent children are defined as your unmarried children who are:

- less than 19 years old and not in full-time employment;
- less than 25 year's old if full-time students in an accredited institution for learning and chiefly dependent on you for support and maintenance.
- incapable of self-sustaining employment by reason of mental or physical handicap, who are chiefly dependent upon you for maintenance and support, are residing in Canada and who became so incapable before attaining age 19.

The term "child" includes any legally adopted child and any stepchild who is primarily or chiefly dependent on the employee.

BENEFIT PLANS

Along with provincial hospital and medical plans, the PFC Health Care Plan provides you with financial security against the high cost of health care.

This brochure is intended as a plan summary. In the event of any discrepancy between the official document and this summary, the official document will prevail.

If you require further information concerning any aspect of your Health Care Plan, please contact your local Human Resources Department.

PROVINCIAL HEALTH INSURANCE PLAN – (OHIP)

This plan provides coverage in two areas:

1. Hospital Expenses

- Standard ward-level accommodation in a hospital
- All normal hospital services while confined, plus
- Certain required out-patient services.

2. Physicians' Services

- Doctors' visits at home, in the office, or in the hospital

- Surgical procedures,
- Diagnostic tests, and
- Specialists' fees.

The Physician is paid a fee for his services which is based on a Province-wide schedule of fees.

The Company will pay the full premium cost of this Plan for employees (excluding probationary employees) providing such Company payment is not prohibited by Law.

EXTENDED HEALTH PLAN

Eligibility

The Post Foods Canada Health Care Plan is offered to regular full time permanent Unionized hourly Niagara Falls employees. You and your eligible dependents are covered under this plan immediately following the probationary period with Post Foods Canada.

As a regular full-time employee, you are also covered for expenses incurred while on lay-off, for a maximum period of six consecutive months.

Cost of the Plan

Post Foods Canada pays the full cost of the coverage provided by the plan for you and your eligible dependents.

Deductible

A deductible of \$25 per person, maximum \$50 per family, is applied every year to all eligible medical and dental expenses combined.

The deductible is the amount of eligible expenses which you must pay in full each calendar year before you can receive a reimbursement of covered expenses. If the eligible expenses you incurred during the first nine months of the year are less than the deductible amount, additional expenses up to the deductible

amount incurred in the last three months of the year may be carried over as a credit towards satisfying the deductible amount of the following year.

Eligible Expenses

The Post Foods Canada Health Care Plan reimburses a percentage of the eligible expenses, provided these expenses are reasonable and customary, and that they are medically necessary and prescribed by a physician. Reimbursement is subject to a lifetime maximum of \$300,000 per insured person.

In addition, up to \$1,000.00 of this maximum will be reinstated each January 1. The actual amount will be based on the amount of benefits you had received from the plan in the previous calendar year.

Hospital Expenses

For licensed hospital and convalescent care facilities, the plan covers:

Hospital:	100% of the difference in cost between ward and semi-private or private room up to \$55 per day and 80% of the excess over \$55.
Convalescent Care:	100% of the cost of semi-private accommodation up to \$55 per day and 80% of the excess over \$55.

Hospitalization outside Canada is reimbursed at 100% of emergency treatment of an illness or accident occurring while traveling outside the country.

If you are hospitalized outside Canada for a medically necessary treatment not available in Canada and for which there is no alternate treatment available in Canada, medical expenses that exceed the allowance paid by any provincial government plan

are reimbursed based on reasonable and customary charges.

No deductible applies to hospital expense.

Medical Expenses

The plan reimburses 100% of the following eligible medical expenses:

Drugs and medicines which require a prescription by law to be obtained.

Reasonable and customary charges for emergency treatment of an illness or accident occurring while traveling outside Canada.

Emergency travel assistance expenses (see leaflet entitled "Emergency Travel Assistance" for full details.)

Medical – Drug Card

The Company is prepared to provide a drug card at 100 per cent reimbursement conditional upon acceptance of the Telus Formulary. The Company will agree to continue coverage for any current prescription for a drug currently being claimed and covered by the Company Drug Plan as of the date of ratification of this agreement regardless of such drug not being covered by the Telus formulary.

The plan also reimburses 80% of the following:

Private-duty nursing. Services must be recommended by a physician and rendered by a registered nurse who is not a relative and does not ordinarily reside in your home. There is a maximum reimbursement of \$10,000 every thirty-six (36) months.

Charges for room and board in a licensed chronic care facility up to a maximum reimbursement of \$10 per day for a period of 120 days per calendar year.

Charges for the use of a licensed ambulance for local

transportation to and from the nearest hospital. Emergency transportation by airline to and from the nearest hospital within your province of residence which is equipped to provide the required medical services is also eligible, subject to a maximum equal to an economy airfare.

Paramedical services by a licensed physiotherapist, psychologist, osteopath, podiatrist, chiropractor, massage therapy, naturopath or speech therapist, up to a maximum reimbursement of \$500 per practitioner each calendar year (hearing and vision are not included in paramedical coverage). In addition, covered expenses include the cost of one X-ray per practitioner each calendar year. To be considered eligible expenses, the services provided must be within the scope of the license held by the practitioner. In addition the company will cover up to \$1,000 for psychologist and or psychiatrist expenses.

Laboratory tests and X-rays for diagnosis not covered by any government plan.

Prescription contact lenses, eyeglasses and laser correction surgery up to a maximum reimbursement of \$500 (including the cost of eye exam) per person every twenty-four (24) months. This reimbursement applies for either contact lenses or eyeglasses but not both.

Dental services required to repair natural teeth damaged as a result of an accident, up to \$5,000, provided the repairs commence within three months of the accident.

Hearing aids up to a maximum reimbursement of \$300 per person every thirty-six (36) months.

Charges for:

Rental or purchase of braces and crutches, and purchases of prostheses required for therapeutic use.

Rental or purchase of a wheelchair, hospital bed, or oxygen

equipment required for therapeutic purposes.

Orthopedic shoes and orthotics prescribed by a licensed physician and required to correct a diagnosed physical impairment. Once the first expense has been paid for by the plan, the cost of replacement will only be covered if it is required as a result of pathological change.

Flash Glucose Monitors (“FGM”) including their supplies (sensors, transmitters) - \$75 per claim for the monitor, to a maximum of \$2,500 per year for the monitor, plus all supplies.

Continuous Glucose Monitors (“CGM”) including their supplies - \$4,500 per year.

Coordination of Benefits

Limitation of Benefit Amount

This provision is applicable to all benefits payable under this plan. Where the total benefits under this plan and other group plans would exceed costs incurred for covered expenses, reimbursement from all plans shall be limited to incurred expenses according to the following order of benefit determination:

- Benefits shall be payable first from another group which does not have a provision to coordinate benefits, then subsequently in accordance with the rules of this and other group plans which do have coordination of benefits.
- Coordination of benefits with other plans excluding Post Foods Canada benefit plans:
- a person covered as an employee under another group plan must claim first under their group plan, and then as a dependent of an eligible employee under the Post Foods Canada plan.
- eligible dependent children must be claimed first under the plan of the employee whose birthday occurs earlier in the

calendar year, and then by the employee covered by a plan.

If priority cannot be established under the above two points, the benefits shall be paid under both plans in a ratio proportionate to the amounts that would have been paid under each plan had there been coverage under just that plan.

Exclusions

The Post Foods Canada Health Care Plan does not cover:

- Services and supplies not included in the list of eligible expenses.
- Charges which are not specifically for treatment covered under this plan.
- Charges for general health examinations.
- Charges for eye examinations. In provinces where Medicare does not cover this expense, examination charges will be included in the maximum reimbursement of \$500 every twenty-four (24) months used for prescription glasses, contact lenses or laser correction surgery.
- Services paid for in part or in totality under any federal or provincial government legislation.
- Cosmetic surgery or treatment, including hospital confinement for such surgery or treatment.
- Charges related to any disability for which benefits are provided under any workers' compensation legislation.
- Dental work where a third party is responsible for payment of such charges.
- Charges related to injury resulting directly or indirectly from war, declared or not, insurrection or riot, or hostilities of any kind.
- Charges for services or supplies which are furnished without the recommendation and approval of a physician

acting within the scope of his or her license.

- Charges related to intentionally self-inflicted wounds.
- Drugs, sera, injectable drugs or supplies that are not approved by Health and Welfare, Canada, and that are experimental or limited in use.
- Charges which are not medically necessary for the care and treatment of any existing or suspected injury, disease or pregnancy.
- Charges made by a physician for travel, broken appointments, communication costs, completion of claim forms or physician's supplies.
- Charges which would not normally have been incurred but for the presence of this coverage or for which the employee or dependent is not legally required to pay.
- Charges for administrative fees, however defined, are not covered.

In the Event of Disability

If you are absent from work due to injury or illness, coverage under the Post Foods Canada Health Care Plan is maintained for you and your eligible dependents, at no cost to you, for as long as you are receiving Post Foods Canada disability benefits.

In the Event of Death

In the event of your death while an active Post Foods Canada employee, coverage under the Health Care Plan continues for your eligible dependents for six (6) months from your date of death.

Termination of Employment

Coverage ceases for you and your eligible dependents at the end of the month in which you terminate your employment with Post Foods Canada. Out-of-Canada coverage ceases on the date of termination of employment. When you retire, you

become eligible for the Post Foods Canada Retiree Benefits.

CLAIMS PROCEDURE

Hospital Expenses in Excess of Provincial Hospital Coverage

When you or an insured dependent are admitted to a hospital, you should request that all invoices for expenses in excess of the provincial limits be sent directly to the insurer. The hospital invoice must be attached to the appropriate claim forms in order to be processed. Payment will be made to the hospital and a statement will be sent to you.

When a hospital refuses to follow this procedure, you must pay the required fee and submit your invoice to the insurance Company for reimbursement of eligible expenses.

Eligible Medical Expenses

- When you pay eligible medical expenses, be sure to obtain receipts which specify the following:
 - name of the patient
 - name of the hospital, laboratory, physician or pharmacist
 - date service was rendered or purchase was made
 - description of the service or purchase
 - the amount charged
 - name of the drug

When your expenses exceed the deductible, obtain a claim form from your local Human Resources Department, complete it and return to the insurer along with original receipts of invoices.

It is recommended that you hold expenses until they exceed the deductible. However, you must provide reimbursable expenses no later than sixty (60) days following the end of the year in which the expenses were incurred.

Payment from the insurer will be paid directly to you. At that

time, the insurer will also supply you with new forms for your next claim.

Claims should be sent to the Insurance Carrier office listed on the claim form.

Licensed Practitioners

In order for expenses of a practitioner to be considered eligible for reimbursement, the practitioner must be licensed and the services rendered must be within the scope of that license.

Reasonable and Customary

Reasonable and customary charges are the amounts measured and determined by comparing them with charges customarily made for similar services and supplies to individuals of similar medical condition in the locality concerned.

DENTAL PLAN

Eligibility

The Dental Care Plan is offered to regular full-time permanent Unionized hourly Niagara Falls employees. You and your eligible dependents are covered under this plan immediately following the probationary period with Post Foods Canada.

As a regular full-time employee, you are also covered for expenses incurred while on a lay-off for a maximum period of six consecutive months.

Cost of the Plan

Post Foods Canada pays the full cost of the coverage provided by the plan for you and your eligible dependents.

Deductible

A deductible of \$25 per person, maximum \$50 per family, is applied every year to all eligible dental and medical expenses combined.

The deductible is the amount of eligible expenses which you must pay in full each calendar year before you can receive a reimbursement of covered expenses. If the eligible expenses you incurred during the first nine months of the year are less than the deductible amount, additional expenses up to the deductible amount incurred in the last three months of the year may be carried over as a credit towards satisfying the deductible amount of the following year.

Eligible Expenses

The Post Foods Canada Dental Care Plan covers 85% of the eligible expenses for three categories of dental care subject to current deductible and annual lifetime maximums:

- Basic Services

- Major Restorative Work

- Orthodontic Treatment

The maximum amount reimbursed for the first two categories combined is \$1,500 per person each calendar year for you and each of your eligible dependents. The lifetime maximum benefit for orthodontic treatment is \$2,000 per person.

Maximum eligible expenses are established in accordance with the current fee guide of the dental association of your province of residence. When several treatment possibilities exist, reimbursement of eligible expenses may be determined based on an alternate benefit.

Basic Services

Diagnostics

- Consultations

- Single diagnostic X-rays

- Complete series of X-rays; once every 24 months
- Oral examinations: once every six months

- Study casts: once per year

Preventive

Scaling and polishing (prophylaxis) once every six months

Topical fluoride

Passive space maintainers (that do not move the teeth) for dependent children only

Oral hygiene instruction once every six months

Minor Restorative Work

Fillings (silver amalgam, silicate, or synthetic restorations)

Stainless steel crowns

Oral Surgery

Removal of teeth, including impacted teeth and residual roots

Anesthesia

Post-operative care

Endodontics

Emergency endodontic procedures and root canal therapy

Periodontics

Treatment of diseases of the gum and other supporting tissue of the teeth

Repair or relining and rebasing of dentures, including addition of new teeth

Major Restorative Work

Gold inlays, onlays and crowns

Note: when a tooth can be restored with silver amalgam, silicate or synthetic restorations, benefits will be determined based on the usual costs of such a restoration.

Replacement of dentures and other dental appliances

Note: After the initial purchase of a dental appliance,

replacement expenses are eligible if the existing dental appliance is at least five years old and no longer serviceable.

Orthodontic Treatment

Correction of malocclusion of the teeth

Full-mouth reconstruction

Coordination of Benefits

Limitation of Benefit Amount

This provision is applicable to all benefits payable under this plan. Where the total benefits under this plan and other group plans would exceed costs incurred for covered expenses, reimbursement from all plans shall be limited to incurred expenses according to the following order of benefit determination:

- Benefits shall be payable first from another group which does not have provision to coordinate benefits, then subsequently in accordance with the rules of this and other group plans which do have coordination of benefits.
- Coordination of benefits with other plans excluding Post Foods Canada benefit plans:
 - a person covered as an employee under another group plan must claim first under their group plan, and then as a dependent of an eligible employee under the Post Foods Canada plan.
 - eligible dependent children must be claimed first under the plan of the employee whose birthday occurs earlier in the calendar year, and then by the employee covered by a plan. If priority cannot be established under the above two points, the benefits shall be paid under both plans in a ratio proportionate to the amounts that would have been paid under each plan had there been coverage under just that plan.

Exclusions

The Post Foods Canada Dental Plan does not cover:

- Services or supplies that are primarily for cosmetic dentistry, e.g., bonding, bleaching and facings.
- Charges which are not specifically for treatment covered under this plan.
- Services paid for in part or in totality under any federal or provincial government legislation.
- Services or supplies not furnished by a legally qualified dentist or denturist.
- Services or supplies necessitated directly or indirectly as the result of committing, attempting to commit or provoking an assault or criminal offence, or by a war or act of war, declared or not, insurrection or riot, or hostilities of any kind.
- Miscellaneous charges such as counseling, travel, broken appointments, communications costs or completion of claim forms.
- Services or supplies resulting from any intentionally self-inflicted wound.
- Any hospital charges for board and room and related services and supplies.
- Any dental examinations required by a third party.
- Services or supplies not medically necessary.
- Services or supplies for implantology, including tooth implantation or transplantation and surgical insertion of fabricated implants.
- Charges for administrative fees, however defined, are not covered.

In the Event of Disability

If you are absent from work due to injury or illness, coverage

under the Post Foods Canada Dental Care Plan is maintained for you and your eligible dependents, at no cost to you, for as long as you are receiving Post Foods Canada disability benefits.

In the Event of Death

In the event of your death while an active Post Foods Canada employee, coverage under the Health Care Plan continues for your dependents for six (6) months from your date of death.

Termination of Employment

Coverage ceases for you and your eligible dependents at the end of the month in which you terminate your employment with Post Foods Canada. When you retire, benefits cease at the end of the month immediately prior to retirement date.

Claims Procedure

When you are planning to visit your dentist, obtain a claim form from your local Human Resources Department. The form should be completed by you and your dentist. You should then send your claim form directly to the insurer.

It is recommended that you hold expenses until they exceed the deductible. However, you must provide reimbursable expenses no later than 60 days following the end of the year in which the expenses were incurred.

Payment from the insurer will be paid directly to you. At that time, the insurer will also supply you with new forms for your next claim.

Claims should be sent to the Insurance Carrier office listed on the claim form.

Pre-Treatment Plan

When a series of treatments is likely to cost more than \$300, the insurer suggests that you submit a treatment plan before treatment begins in order to determine the amounts payable.

under the plan.

A treatment plan is a written description by your dentist of the required treatment and the cost of this treatment. Typically, the dentist will complete a standard claim form indicating the services that will be performed and will provide X-rays.

Licensed Practitioners

In order for expenses of a practitioner to be considered eligible for reimbursement, the practitioner must be licensed and the services rendered must be within the scope of that license.

Reasonable and Customary

Reasonable and customary charges are the amounts measured and determined by comparing them with charges customarily made for similar services and supplies to individuals of similar medical condition in the locality concerned.

LIFE INSURANCE PLAN

Eligibility

The Life and Accident Insurance plans are offered to all regular full- time permanent Unionized hourly employees. You are eligible for coverage under these plans following completion of the probationary period.

You must apply for the optional insurance plans for you and your eligible dependents within three months from your probationary period with Post Foods Canada. Optional AD&D becomes effective upon enrollment. You can apply for Optional Life Insurance at any time after becoming eligible in the basic plan, subject to evidence of insurability.

In order to select AD&D coverage for your dependents, you must also select AD&D coverage for yourself. Coverage may be changed any January 1. However, approval by the insurance Company is required to increase your Optional Life coverage.

Basic Life Insurance

Amount of Coverage

Under the Basic Life Insurance Plan, you are insured by an amount equal to one times your annual base salary. This amount is paid to your beneficiary if you die from any cause.

Cost of Plan

Post Foods Canada pays the full cost of the coverage provided by the Basic Life Insurance Plan.

Retirement Insurance

If you retire from Post Foods Canada while on active status, Post Foods Canada will assume the full cost of providing you with Life Insurance coverage in the amount of \$2,000, provided that you are age 55 or more and have at least 10 years of service with the Company at the time of retirement.

Optional Life Insurance Amount of Coverage

The Optional Life Insurance Plan provides you with the opportunity to purchase additional amounts of life insurance, if you need it. This extra-coverage is available in units of \$10,000 for up to 8 times your base salary and is payable to your beneficiary upon your death.

You may also purchase coverage for your spouse and children. Coverage for your spouse may be obtained in units of \$10,000 up to 50% of your own coverage, with evidence of good health. Coverage for children is \$5,000 per child.

In the event of the death of one of your insured dependents, the amount of coverage will be paid to you.

Cost of the Plan

Optional Life Insurance is paid for entirely by you. The cost of coverage for you and your spouse is based on the amount of insurance you select and on your respective ages.

OPTIONAL ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE PLAN

The Optional AD&D plan offers a full 24-hour, 365-day-a-year coverage against accidents occurring anywhere in the world, whether you are on or off the job.

Amount of Coverage

Under this plan, you may purchase accidental death and dismemberment coverage up to \$500,000 in units of \$10,000 for yourself. You may also request coverage for your spouse of up to 50% of your own coverage, in units of \$10,000. Each child may be insured for \$5,000.

The full amount of insurance is payable if death is the result of an accident. In the event of accidental dismemberment and other physical losses, a percentage of the amount of insurance may be payable, for example:

Loss of life, both hands, both feet, the entire sight in both eyes, or any combination thereof	100%
Loss of one arm or leg	75%
Loss of use of one arm or one leg	75%
Loss of one hand, one foot or sight in one eye	66-2/3%

In the event of your accidental death while insured, the amount of insurance will be paid to the beneficiary. All other indemnities are payable to you.

Cost of Plan

The cost of the Optional AD&D Insurance Plan is entirely paid for by you, based on the amount of insurance you select.

Exclusions

The AD&D plan does not cover losses resulting from the following:

- suicide or self-destruction, or any attempt by the insured person while sane or insane,
- flying in any aircraft or other airborne vehicle as a pilot, operator or member of the crew,
- declared or undeclared war or any act thereof,
- active full-time service in the armed forces of any country.

Additional Information Beneficiary

When you enroll in the Life and AD&D Insurance Plans, you designate the beneficiary or beneficiaries of your choice on the application form. You may change this designation at any time, unless it is specified that your designation is irrevocable or

such change is prohibited by law. However, no change of beneficiary is binding until all necessary documents are received by the Human Resources Dept.

If you die, the last beneficiary you designated in writing will receive the benefits according to the coverage in effect. You may also designate your estate as beneficiary.

In the event of the death of one of your insured dependents, the insurance proceeds will be paid to you.

Coverage During a Leave of Absence

You may maintain your coverage under the Life and Accident Insurance plans for up to one year, while on approved leave of absence, by continuing your contributions. Otherwise, your coverage will cease at the end of the month in which your contributions stop. Upon your return, the insurance Company would then require satisfactory evidence of insurability for you and your dependents before your coverage can be reinstated.

Conversion Option

If your employment terminates, you may convert your basic and optional life insurance to an individual policy without having to provide evidence of good health.

To exercise your conversion privilege, you must contact the insurance Company and request the conversion of your insurance within thirty-one (31) days of your termination of employment. Forms for this purpose are available from the Human Resources Dept.

In the Event of Disability

If you are eligible for disability benefits under the Post Foods Canada Short-Term or Long-Term Disability Plans, you and your insured dependents remain covered under both the Basic and Optional Life Insurance Plans for as long as you remain disabled and receiving benefits, but not later than age 65.

While you are receiving Short-Term Disability Benefits, you continue to pay any required premiums. When you receive Long-Term Disability Benefits, your premiums may be waived.

Optional AD&D coverage continues while you are receiving Short-Term Disability Benefits provided premiums are paid, but ceases after you receive Long-Term Disability Benefits for two (2) years.

Termination of Employment

All insurance coverage will cease at the end of the month in which you leave Post Foods Canada. However, should you die during the thirty-one (31) days, the full amount of your Life Insurance is payable.

In the Event of Death

In the event of your death while in the employment of Post Foods Canada the optional insurance you may have elected for your spouse and your children ceases.

NON-OCCUPATIONAL ACCIDENT AND SHORT-TERM DISABILITY PLAN

The purpose of your Post Foods Canada disability coverage is to ensure a continuous income, should you be unable to work because of a non-occupational illness or injury.

This coverage includes:

- A **Short-Term Disability Plan**, which covers disabilities of up to twenty-six (26) weeks, and
- A **Long-Term Disability Plan**, which covers disabilities that extend beyond this 26-week period.

This brochure is intended as a plan summary. In the event of any discrepancy between the official document and this summary, the official document will prevail.

If you require further information concerning any aspect of your

disability benefits, please contact your local Human Resources Department.

Short-Term Disability Plan

Eligibility

As a regular full-time permanent Unionized hourly Niagara Falls employee, you are eligible for coverage under the Short-Term Disability Plan upon completion of your probationary period, providing you show disability due to a non-occupational accident or sickness which, in the Company's judgement, prevents you from performing normal work assignments.

You must be actively at work to be eligible for benefits. If you become disabled while on a leave of absence or vacation or on lay-off, or while on strike, suspension from work or otherwise not actively employed, your eligibility will begin on the first day on which you would have returned to work had you not been disabled, and absence on this day will be deemed your first day of absence for benefits purposes.

The Company agrees to provide an Annual meeting with the benefit carrier.

Cost of the Plan

Post Foods Canada pays the cost of all benefits provided under the Short-Term Disability Plan.

Benefits

The disability benefits under the Short-Term Disability Plan are payable for a maximum of 26 weeks, as follows:

Basic Benefits

You are credited with 10 days of Basic Benefits upon attainment of seniority and with 10 additional days on your employment anniversary in each subsequent year of continuous employment, up to a maximum of 130 days.

When you are disabled, you will receive 75% of your basic rate of pay, from the third scheduled work day of disability and for the number of days of Basic Benefits you have to your credit, as long as the disability continues.

The two-day waiting period is waived if the disability results from an accident or if you are hospitalized.

In addition, if you remain disabled for fourteen (14) calendar days beginning with the first day of disability, the waiting period will also be waived and Basic Benefits will be paid retroactively to the first day of disability, provided you still have Basic Benefits available.

When you return to work after an absence, the Basic Benefits period is fully reinstated once you have been back at work for at least four (4) weeks.

Supplemental Benefits

If you remain disabled after all Basic Benefits to which you are eligible have been paid, supplemental benefits amounting to 60% of your basic rate of pay will be payable for the rest of the 26-week period. Supplemental Benefits are payable for a maximum of 26 weeks in any calendar year.

No supplemental or Basic Benefits are payable until you have submitted an Attending Physician's Statement attesting to the nature and severity of the disability, and certifying that the disability precludes you from performing your regular work assignments.

STD for Pregnant Employees

Pregnant employees with written medical restrictions will be accommodated. If the employee cannot be accommodated, the employee will be eligible to apply for Short Term Disability, which shall be adjudicated by the insurance provider based on the medical documentation provided. Such eligibility for Short Term Disability shall be up to six (6) weeks prior to the scheduled birth

of the child at which point the ESA pregnancy leave shall commence.

Taxation Status of Benefits

Basic and supplemental Disability Benefits payable under this plan are considered taxable income.

Part-Time Employment During Disability

If your disability prevents you from working full days, you will be provided with part-time employment for the duration of disability, if available. If you are eligible for Basic Benefits, you will receive full pay for your hours worked, and, after the two-day waiting period, Basic Benefits for the hours not worked within the working day.

If you are not eligible for Basic Benefits, you will receive full pay for your hours worked and supplemental benefits for the hours not worked.

Each partial working day will be considered a full day for purposes of determining the maximum benefits period.

Discontinuance of Benefits

Short-term disability benefits cease upon your recovery, retirement, death or at the end of the 26-week period, whichever occurs first.

If, while receiving benefits, you are discharged or would not have worked due to strike or suspension of employment, you cease to be eligible for benefits after the day on which such event occurs.

However, where lay-off provisions exist and you are disabled when a lay-off begins, your benefits will continue for a maximum of fifteen (15) weeks from the date the disability began.

Recurrence of Disability

If you become disabled for the same or a related reason within thirteen (13) weeks following your return to full-time permanent

work after a short-term disability, the second disability period will be considered a continuation of the first. Benefits would then resume as if you had not returned to work.

If the new disability is not related to the first, and provided that you have returned to full-time permanent work for at least four (4) weeks, you will begin a new benefit period, and the Basic Benefit period will be reinstated.

LONG-TERM DISABILITY

Eligibility

You are covered under the Long-Term Disability Plan upon completion of your probationary period. You become eligible for long-term disability benefits if your disability continues for more than twenty six (26) weeks, provided that you are totally disabled and under the care of a legally qualified physician at all times.

For the purposes of the Long-Term Disability Plan, total disability means that, for the first two (2) years of benefit payments, you are unable to perform the duties of your current job, and that, after two (2) years, you remain unable to perform the duties of a job related to your skills and experience.

Medical reports will be required periodically.

Cost of the Plan

The Long-Term Disability Plan is full paid for by Post Foods Canada.

Benefits

The plan provides you with a monthly income equal to 67% of the monthly base salary you were receiving when you became disabled, up to a maximum benefit of \$15,000 per month. Benefits payable under the plan are considered taxable income.

Long-term disability benefits may be paid to the earliest of recovery, death or age 65.

Recurrence of Disability

If you become disabled for the same reason within six (6) months of your return to full-time permanent work after a long-term disability, the second disability period will be considered a continuation of the first. You will then immediately begin receiving your long-term disability benefits.

If the period exceeds six months or if the new disability is not related to the first, a new claim must be filed under the Short-Term Disability Plan.

Rehabilitative Employment

As an incentive to promote an early return to gainful employment after a total disability, you may perform certain work without forfeiting the benefits payable under the Long-Term Disability Plan.

If you engage in an approved rehabilitative employment program, you will be entitled to receive your long-term disability benefits over and above the employment income payable from the program.

The rehabilitation benefits may be paid for a maximum period of twenty-four (24) months during which your income from all sources must not exceed your gross earnings at the time you became disabled.

Should disability prevent you from continuing with the program, your regular disability benefits will continue to be paid.

Co-ordination with Other Sources of Income

Long-term disability benefits are reduced by disability benefits payable from Workers' Compensation, the Canada Pension Plan (excluding any payments for your dependent children) and by any other income from employment or other government plans.

Continuation of Other Employee Benefits During Disability

If you are receiving disability benefits under the Post Foods Canada. Short-Term or Long-Term Disability Plans, you remain covered under the Health Care, Dental Care and Basic Life Insurance Plans for as long as you remain disabled, but not later than age 65. Optional Life may be continued if premiums are paid.

Optional AD&D coverage continues while you are receiving short-term disability benefits and long-term disability benefits for the first two (2) years of benefit payments, provided premiums are paid.

Coverage ceases after long-term disability benefits have been in effect for two (2) years.

While you are receiving short-term disability benefits, you continue to pay any required premiums. When you receive long-term disability benefits, your premiums may be waived.

Your membership in the Retirement Plan may be maintained while you are receiving long-term disability benefits. You will receive credited service by making the required contributions to the Plan. If you do not make the necessary contributions to the Plan, no further service will accrue while on disability.

Exclusions

No short-term or long-term disability benefits are payable for:

- A disability arising from or in the course of employment by another employer, where you had an employee/employer relationship with the other employer and received remuneration for your services.
- A disability for which you may be entitled to indemnity in accordance with the provisions of a Workers' Compensation Plan, the Canada Pension Plan, a provincial auto insurance plan or a group benefit plan.
- A disability caused by or resulting from a self-inflicted

injury or illness.

- A disability caused by or resulting from use of alcoholic beverages, stimulants, drugs or narcotics, unless you are participating in a Post Foods Canada sponsored rehabilitation program.
- A disability resulting from acts of immorality or fighting. A disability occurring while violating a Company rule.

Claims Procedure

When you become ill or injured and unable to report to work, the following procedure should be followed:

- On the first and each subsequent day, advise your supervisor of your absence and expected date of return to work.
- Submit an Attending Physician's Statement to establish eligibility for benefits.

The Company, at its expense and discretion, may require an examination by a physician or nurse of its choice. Failure or refusal to submit to such examination will render you ineligible for benefits.

Termination of Coverage

Coverage under this Plan terminates on the earlier of termination of employment, death or retirement.

RETIREMENT PLAN

Individuals hired on or after April 1, 2012 will not be eligible to participate in the defined benefit retirement plan set forth in this Appendix. Retirement benefits for these individuals will be provided through a separate Defined Contribution Pension Plan. Details are included in a Letter of Understanding.

NOTE: Retirement income provided by Kraft Canada in respect to benefits earned prior to August 4, 2008 are subject to the provisions outlined in the Kraft Canada Inc. Retirement Plan for

Niagara Falls Hourly Cereal Division Employees (Kraft Canada Plan). Post Foods Canada Inc. is not responsible for the administration of that plan, and will rely solely on the information provided by Kraft Canada in respect to frozen benefit information as being true and accurate. Any questions arising from the administration of the Kraft Canada Plan should be addressed directly with Kraft Canada.

Eligibility and Enrollment

As a full-time permanent unionized hourly Niagara Falls employee, you become eligible to join the plan on the first of the month following or coincident with completion of one year of service with Post Foods Canada.

If you are a temporary employee, you become eligible when you have completed two years of service, provided that you have earned 35% of the Year's Maximum Pensionable Earnings* in each of those years or worked 700 hours for Post Foods Canada during each of those years. Contributions and benefits will be prorated on the basis of hours worked.

You may join at any time after becoming eligible by signing the enrollment form authorizing Post Foods Canada to deduct the required contributions from your earnings and designating a beneficiary. Enrollment forms are available through the Human Resources Department.

*The Year's Maximum Pensionable Earnings, or YMPE, is the maximum amount of earnings that can be used to determine an individual's benefits under the Canada Pension Plan. It is adjusted each year to reflect average Canadian wage levels.

Contributions

Effective January 8, 2000, you contribute \$101 per month (\$ 2.00 per month reduction from the formula to provide seed monies for investment in the OPP/ESP) through payroll deductions.

Effective January 1, 2005; you contribute \$103 per month.

Ontario pension laws mandate that your contributions made after January 1, 1987, cannot represent more than 50% of the value of the pension accumulated after that date. Any excess will be reimbursed to you upon retirement or termination, or to your spouse or beneficiary, should you die before retirement.

Company contributions: Post Foods Canada contributes the amounts required, in addition to your own contributions, to finance the retirement, termination, death and other benefits to which you are entitled.

Benefits at Retirement

Your normal retirement date is the first day of the month following your 65th birthday. However, you may retire as early as the first day of any month following your 55th birthday.

Starting from your normal or early retirement date, you will receive a pension payable monthly throughout your lifetime.

Normal Retirement

If you retire at age 65, you will receive an annual pension calculated as follows:

Service prior to January 1, 1994:

Retirement income earned in respect of Credited Service prior to January 1, 1994 will be equal to (i) MINUS (ii) where:

- (i) is Pre-1994 Credited Service multiplied by (a) minus (b) where:
 - (a) is 1.5% of Final Average Earnings; and
 - (b) is 0.4% of the lesser of Final Average Earnings and the YMPE Average

Where Pre-1994 Credited Service is periods of eligible service earned prior to 1994 while a member of the Kraft Canada Plan or predecessor plan, up to a maximum of 40 years; and

Final Average Earnings are the average of the best three (3)

consecutive years out of the last ten years of Continuous Service with Kraft Canada and with Post Foods Canada prior to your termination of employment, death or retirement, whichever occurs first;

AND

- (ii) the frozen retirement income earned, if any, under the Kraft Canada Plan in respect of Pre-1994 Credited Service.

Service after December 31, 1993:

Effective August 4, 2008, \$53 per month for each year of post-1993 Credited Service you have accumulated, less the frozen retirement income, if any, earned under the Kraft Canada Pension Plan in respect of service after December 31, 1993.

Effective April 1, 2009, \$54 per month for each year of post-1993 Credited Service you have accumulated less the frozen retirement income, if any, earned under the Kraft Canada Plan in respect of service after December 31, 1993.

Effective January 1, 2010, \$55 per month for each year of post-1993 Credited Service you have accumulated less the frozen retirement income, if any, earned under the Kraft Canada Plan in respect of service after December 31, 1993.

Effective January 1, 2011, \$56 per month for each year of post-1993 Credited Service you have accumulated less the frozen retirement income, if any, earned under the Kraft Canada Plan in respect of service after December 31, 1993.

Your post-1993 Credited Service is your number of years and complete months of continuous service while a member of the Kraft Canada Plan or Post Foods Canada Plan to the date of retirement, termination of employment or death, whichever occurs first. For any periods after 1994, Credited Service does not include any periods for which you made no contributions while eligible to contribute in the Plan. In addition, no credits will

be given for periods of military service, unless contributions are made upon return to active service.

NOTE: The Company has filed a determination with the Canada Revenue Agency (CRA) for approval to replicate certain benefit provisions of the Kraft Canada, Inc. Retirement Plan and to treat Kraft Canada and Post Foods Canada Inc. as one employer for the purposes of determining the Final Average Earnings. The benefit formula outlined above assumes approval is granted from CRA. If approval is not granted by CRA, the provisions of the Post Foods Canada Inc. Retirement Plan will apply. Based on CRA's determination, the Company and the Union will meet to discuss and agree upon any changes to the above section of this Appendix.

Early Retirement

If you retire before age 65, your pension will be calculated as above. A reduction of 3% for each year that your retirement precedes age 60 will apply to the pension earned after January 1, 1994 less the frozen retirement income earned, if any, under the Kraft Canada Plan. For service prior to January 1, 1994, the benefit that you earned less the frozen retirement income, if any, under the Kraft Canada Plan in respect of the pre-1994 Credited Service, will be reduced by 5% for each year that your retirement precedes age 62.

For employees that retire from active employment after ratification of the 2003 contract and who are 60 or older at the time of retirement, the pre-1994 benefit early retirement reduction factor will not apply. For employees who retire prior to age 60 the pre-1994 benefit less the frozen retirement income, if any, under the Kraft Canada Plan in respect of the pre-1994 Credited Service, will be reduced 5% for each year prior to age 62.

In addition, the plan provides a supplement to all participants who elect early retirement from active service between the ages

of 55 and 65. Effective after ratification, the amount is equal to \$160 per year multiplied by your Continuous Service to a maximum of 35 years, then reduced by the frozen bridge benefit, if any, earned under the Kraft Canada Plan.

This bridging supplement starts on your early retirement date and stops on the first day of the month following your 65th birthday or at your death, whichever comes first.

Forms of Pension Payment

Normal Form of Payment

Your pension payments start when you retire and are paid for life.

If you have a spouse at the time you retire, pension legislation requires that 60% of your pension be continued to your spouse upon your death, unless you and your spouse choose to renounce this benefit prior to your retirement.

Effective with retirements after ratification of the 2003 contract, the 10% reduction applied to pension earned after January 1st, 1994 less the frozen retirement income, if any, under the Kraft Canada Plan in respect of the pre-1994 Credited Service, for Joint and Survivor pensions shall be eliminated. The Company shall have the unilateral right to re-implement a Joint and Survivor reduction provision for future service in the event such changes are implemented in the Post Foods Canada Retirement Plan for Non Unionized Hourly paid employees.

The pension earned prior to January 1, 1994 less the frozen retirement income, if any, under the Kraft Canada Plan in respect of the pre-1994 Credited Service, will be actuarially reduced to provide the spousal benefit.

To renounce this benefit, you must submit a Spousal Pension Waiver form, which requires the witnessed signature of your spouse.

Optional Forms of Payment

Other forms of pension are available. For example, you may elect a pension with a guaranteed payment period, or you may elect to have part of your pension continued to a joint annuitant after your death. If you retire before age 65, you may also elect a level income option, which provides for a stable flow of income throughout retirement. Each specific option will result in a particular adjustment to your normal pension.

All options available will be fully explained to you prior to retirement. To help you choose the form of your pension, you may request a statement showing the amount of pension available under each option.

Disability Benefits

If you become disabled before your normal retirement date and are eligible to receive disability benefits under the Post Foods Canada Long-Term Disability Plan, you may continue to accumulate credited service during your disability by making contributions to the Plan. If you do not make the necessary contributions to the Plan, no further service will accrue while on disability.

Death Benefits

Death Before Retirement

If you die before retirement, your spouse or your designated beneficiary will receive:

the value of your pension accumulated from January 1, 1987 less the value of the pension accumulated under the Kraft Canada Plan;

plus

the excess, if any, of your contributions made from January 1, 1994 less any contributions made under the Kraft Canada Plan, over 50% of the combined value of the pension as

indicated above.

If you die after attaining age 55 and completing fifteen (15) years of continuous service, your spouse will receive an immediate retirement income in respect to your credited service prior to January 1, 1994 less the retirement income payable under the Kraft Canada Plan.

Death After Retirement

If you die after your pension payments have begun, and you waived the spousal benefit, your beneficiary will receive the excess of your contributions with interest over the amount you have received in pension, if any.

Termination of Employment

If you leave Post Foods Canada before having completed two years of plan membership, you receive a refund of the contributions you made to the Plan, with interest.

However, if you have completed at least two years of plan membership, you are entitled to receive:

A deferred pension from age 65 equal to the pension benefits you have earned from January 1, 1987 up to your termination date less the frozen retirement benefit earned under the Kraft Canada Plan;

Plus

the excess, if any, of your contributions made from January 1, 1994 less any contributions made under the Kraft Canada Plan, over 50% of the combined value of the pension as indicated above.

However, if you leave your employment with Post Foods Canada after having completed 10 years or more of service and you are at least age 45, you may not elect to receive a refund of your contributions. You will receive a pension from age 65 based on

your Credited Service and the Plan provisions in effect on your termination date.

You may choose to receive a deferred pension starting at any time between ages 55 and 65. If you elect to receive your pension before age 60, your pension will be reduced to account for the greater number of years over which it is expected to be paid.

Portability

If you are under age 55 when your employment with Post Foods Canada terminates, the plan allows you to transfer the commuted value of your vested pension to other retirement investment vehicles, such as:

- Another employer's pension plan, if that plan permits the transfer, or
- A locked-in retirement vehicle, or
- An insurance Company for the purchase of a life annuity.

A locked-in retirement vehicle is simply another plan or contract in which funds are used to purchase a pension at retirement.

SAVINGS PROGRAM

Effective June 1, 1997

Eligibility:

The Optional Pension Plan (OPP) and Employee Savings Plan (ESP) are part of the Savings Program. To be eligible for the Optional Pension Plan, you must be a participant of the Retirement Plan. The Employee Savings Plan is open to all employees following their probation period.

Effective June 1, 2003, you may contribute up to a maximum of six (6%) percent of your wages, including overtime. Post Foods Canada will make contributions equal to forty (40%) percent of

your contributions. In other words, for each dollar that you will contribute to the program, Post Foods Canada will contribute forty (\$0.40) cents.

In addition, you may make contributions in excess of 6% to the ESP. The limit on the ESP contribution level is 10%.

You cannot contribute more than 16% of your pay to the OPP and ESP combined.

The Company matching contribution will be eliminated effective April 1, 2009.

Detailed information on the Program is contained in the Employee Booklet.

EMPLOYEE ASSISTANCE PROGRAM

Effective January 8, 2000

Eligibility

The EAP Program is offered to regular full-time unionized hourly Niagara Falls employees and their eligible dependents, following the employees' probationary period with Post Foods Canada.

Cost of Plan

Post Foods Canada pays the full cost of the coverage provided by the plan for you and your eligible dependents.

- participate jointly in information/education sessions and pre- retirement seminars for hourly employees.
- as a committee, to surface issues and concerns to gain joint understanding on results.
- At each meeting, the Company will provide a report including, but not limited to, pension amendments, funding

status and itemized administration costs as soon as possible, but not later than September 1st of each year. This will be an in- house report, as the Company does not file an Actuarial Report with the Government every year, but every three (3) years.

- the meeting shall include, as needed a representative from the Company administrator.
- attend an annual meeting with Company benefit representatives to review:
 - how funds are structured
 - where funds are invested
 - performance of funds invested
 - where Investment Managers are planning to invest funds over the next twelve (12) months

This meeting will take place by November 1st of each calendar year.

This letter of Understanding is included for historical purposes.

1. As a result of Ralcorp Holdings, Inc. acquisition of the Niagara Falls, Ontario facility, the Company and the Union recognize that the Benefits set forth in Appendix A of the Collective Agreement are now provided by the Company rather than Kraft Foods Canada, Inc. Such benefits will be maintained during the duration of the new Collective Agreement, except as otherwise agreed by the Company and the Union during negotiations.
2. The Company and the Union further recognize and agree that following the acquisition, the Retirement Plan benefits under Section 8 of Appendix A are provided pursuant to the Post Foods Canada Inc. Retirement Plan rather than the Kraft Canada, Inc. Retirement Plan. Consistent with the change in plans, certain provisions of Section 8 need to be rewritten to reflect the plan provisions. Additionally, the Company and the Union understand that the Company will make a filing with the appropriate federal or provincial government agencies seeking a determination that the Company may reproduce the benefit formula of the prior Nabisco Plan within the Kraft Canada, Inc. Retirement Plan as if Kraft Foods Canada, Inc. and the Company were one employer. Provided the governmental approval is issued, the

Company agrees that (a) the calculation of the final average earnings under this benefit formula will be updated to the date of the employee's retirement, termination or death, whichever is applicable, considering earnings both before and following the acquisition date and (b) it will have the right to reduce the retirement benefit in respect of service prior to August 4, 2008 by any amounts received from the Kraft Canada, Inc. Retirement Plan, but not reducing to less than zero. If governmental approval is not issued, the provisions of the Post Foods Canada Inc. Retirement Plan will apply to employees. Provided further, service prior to January 1, 1994 shall not be less than the service under the prior Nabisco Plan within the Kraft Canada, Inc. Retirement Plan. Based on the government's determination, the Company and the Union will meet to discuss and agree upon any changes to Section 8 of Appendix A, as well as honor the intent of the parties to recognize the service prior to January 1, 1994 under the prior Nabisco Plan.

3. The Company and the Union further acknowledge that any other clean up items related to the change in benefit plan providers will be incorporated into Appendix A in the new Collective Agreement once agreed upon. Such agreement shall not be unreasonably withheld. The Company and the Union also agree that the definition of "common law spouse" will be modified to comply with Ontario law.

This written notice shall provide the Union with available information on the nature of the work.
3. Layoff Recall When employees are on layoff and work has

been outsourced, the Company will evaluate whether there are opportunities to in-source work in order to alleviate the layoffs.

Company contribution – 6% of employee’s weekly gross earnings.

Employee contribution – 2% of employee’s weekly gross earnings.

The Company will pay the cost of setting up and administering the plan. The Company shall have the right to select the provider of the plan. In the event any issues arise related to the implementation of this plan, the Company and the Union will meet to review and agree on any such issues. Such agreement shall not be unreasonably withheld.

3. The Company and the Union further acknowledge that any other clean up items related to the change in benefit plan providers will be incorporated into Appendix A in the new Collective Agreement once agreed upon. Such agreement shall not be unreasonably withheld.
4. In addition, for employees who participate in the Defined Benefit Pension Plan, the Company will provide 1.5% per hour worked contribution to all employees' Defined Contribution Pension Plan. Employees have the opportunity to contribute to the Defined Contribution Pension Plan in accordance with its terms.

The Company and the Union agree that, depending on individual circumstances, invisible disabilities may call for creative solutions and empathetic approaches when considering accommodation in the workplace and they agree to work in good faith to achieve these ends.

If a Flex worker is hired full time, seniority as between any Flex Workers hired at the same time shall be determined by the highest number of hours worked as a Flex Worker.

Flex workers cannot perform skilled work, including the Cluster Blender classification.

Flex workers will be eligible for reimbursement, for safety shoes and safety glasses after 60 days of employment

The parties recognize the opportunity associated with increased volume and the need to address how increased production levels impact the Company and the Union. Increased volume demands have made it challenging to execute the schedule and have significantly increased overtime requirements.

A strategy has been developed to implement a new overnight weekend cleaning crew (W Shift) as well Supplemental Weekend Employees to partially address these problems. This letter provides the conditions by which these new crews will be implemented.

The Union and the Company agree to the following:

On each scheduled week of production, weekly cleaning overtime will be offered to regular production employees at minimum guaranteed levels for both Saturday and Sunday A shift.

A minimum of thirteen (13) overtime requests will be made on both Saturday and Sunday for such shifts.

MEMORANDUM OF AGREEMENT – W SHIFT – OVERNIGHT WEEKEND CREW

This Memorandum of Agreement is supplemental to the

Collective Agreement entered into by and between Post Foods Canada Inc., Niagara Falls, Ontario and UNIFOR Local 1101. The parties agree that it is in their mutual interest to ensure that the Company remains competitive and reaches the highest levels of productivity possible. To this end, the parties enter into the following Memorandum of Agreement.

The signing of this Memorandum of Agreement and the understandings contained herein shall supersede and override certain conflicting provisions of the Collective Agreement only as they apply to employees employed as part of the weekend crew. It is understood that this Agreement is necessary to clarify the conditions and terms of employment under which individuals will work on weekend crews. To the extent not addressed in this Memorandum, the provisions of the Collective Agreement will apply. The Company and the Union will meet to discuss any unforeseen issues resulting from the implementation of this language.

Hours of Work

The normal hours of work for individuals assigned to the W Shift will be one eight (8) hour shift and two twelve (12) hour shifts.

1st Day: Thursday 3:00 pm to Thursday 11:00 pm

2nd Day: Friday 6:00 pm to Saturday 6:00 am

3rd Day: Saturday 6:00 pm to Sunday 6:00 am

Rate of Pay

The W Shift rate of pay will be 25% over the contractual base rate of the job during the designated hours above.

W Shift Rate = Schedule A or B Base Rate x 1.25

Examples:

The Base Rate for a Sanitarian is \$29.36. A W Shift Sanitarian position will be paid at the rate of \$36.70 (\$29.36 X

1.25).

The Base Rate for a Millwright is \$35.92. A W Shift Millwright position will be paid at the rate of \$45.90 (\$35.92 X 1.25).

The same will apply for all positions posted for this shift.

Overtime

Employees will not be eligible for overtime on their second and third scheduled days due to having already been scheduled for 12 hours of work on those days.

Employees will be eligible for overtime on their first scheduled day if required and if they volunteer to work more than their 8-hour scheduled shift. Overtime worked performing their W Shift job will be paid at 1.5X the W Shift rate of pay. Overtime performed for any other roles being covered will be paid at 1.5X the contractual base rate of that job.

W Shift Overtime Rate = W Shift Rate x 1.5

All other overtime is paid at time and one half (1.5X) the contractual base rate of the job, up to 40 hours worked. All hours worked above 40 hours will be paid at double time (2.0X) the base rate of pay. Their W Shift rate of pay shall not apply to overtime worked outside of their normally scheduled position.

Example: W Shift Sanitarian works 2 hours of overtime on their third day and volunteers to take a shift as a MOD builder on Tuesday and Wednesday

Daily Rates of Pay

1st Day: $\$29.36 \times 1.25 = \36.70 for 12 hours

2nd Day: $\$29.36 \times 1.25 = \36.70 for 12 hours

3rd Day: $\$29.36 \times 1.25 = \36.70 for 8 hours

$\$29.36 \times 1.25 \times 1.5 = \55.05 for 2 hours

4th Day: $\$28.87 \times 1.25 = \43.31 for 6 hours
(40 hours worked)
 $\$28.87 \times 2.0 = \57.74 for 2 hours

5th Day: $\$28.87 \times 2.0 = \57.74 for 8 hours

General overtime will be administered in accordance with Article 28.16.

Probationary Period

No seniority rights are recognized during the first ninety (90) days of work or 720 hours of regularly scheduled time. This will be the probationary period of any new W Shift employees. On completion of the probationary period, the seniority date shall extend back to date of hire. Upon completion of the probationary period, W Shift employees shall become members of the Union in accordance with Article 6 of the Collective Agreement.

Number of days working

W shift employees can only work 3 days in a week unless agreed to with the President or designate

Job Transfers

Job openings for the W Shift shall be posted twelve (12) days in advance of the permanent filling of any vacancy or newly created job. The Company agrees to fill positions in order of seniority, subject to the individual's qualifications.

Employees who transfer into one of these positions from a regular Monday to Friday crewed position will have two work week periods following the start of their W Shift pattern to rescind the position. Newly hired employees will not be able to rescind the position once accepted.

W Shift employees will be assigned to the shift for a minimum period of two years unless otherwise agreed by the Company and the Union. Following that, W Shift employees may apply for a position within the Monday to Friday crew when vacancies occur in accordance with the process set forth in the Collective Agreement. W Shift employees will not be eligible to transfer to the Monday to Friday operation while those employees are awaiting recall from layoff.

Lunch/Break Periods

Lunch and break periods for the W Shift when working 12 hours on the first two scheduled days will include two (2) thirty (30) minute meal periods and one (1) fifteen (15) minute break period at times determined by the Company.

Lunch and break periods for the W Shift when working 8 hours on the third scheduled day will include one (1) thirty (30) minute meal period and two (2) fifteen (15) minute break period at times determined by the Company.

Benefits

The Company will provide the same benefits to weekend crew employees as it does to regular employees.

Holiday Pay

W Shift employees will receive 8 hours of pay at the base rate for the 10 holidays observed within the Collective Agreement. The normal holiday eligibility requirements of the Collective Agreement shall apply to W Shift employees.

Employees will be expected to work all holidays that occur within a regularly scheduled work week when the plant is in operation.

In lieu of the three additional paid days in paragraph 2 of Article 31.01, W Shift employees will be entitled to elect to take (2) 12-hour additional paid days per year at their request.

Vacation

A week of vacation is equal to thirty-two (32) hours at the employees W Shift rate which is equal to 40 hours of the base rate.

Re: Supplemental Weekend Employees

This Memorandum of Agreement is supplemental to the Collective Agreement entered into by and between Post Foods Canada Inc., Niagara Falls, Ontario and UNIFOR Local 1101.

The parties agree that it is in their mutual interest to ensure that the Company remains competitive and reaches the highest levels of productivity possible. To this end, the parties enter into the following Memorandum of Agreement.

The signing of this Memorandum and the understandings contained herein shall supersede certain provisions of the Collective Agreement only as they apply to supplemental employees who are employed for weekend operations. It is understood that this Agreement is necessary to clarify the conditions and terms of employment under which individuals will work on a part time basis to support skilled weekend production activities. These individuals will receive all required training to work on existing plant jobs. To the extent not addressed in this Memorandum, the provisions of the Collective Agreement will apply. The Company and the Union will meet to discuss any unforeseen issues resulting from the implementation of this language. This agreement will terminate at the end of the current collective agreement.

There shall be a maximum of (6) supplementary Weekend Workers. These individuals shall not be eligible to work on bid jobs. In the event of a job posting these individuals shall be eligible ahead of flex workers.

Hours of Work and Rate of Pay

The normal hours of work for individuals successful in securing a supplemental weekend position would be twelve (12) hours per day and twenty-four (24) hours per week.

Twelve (12) hours on Saturday

Twelve (12) hours on Sunday

Hours worked will be 7 a.m. to 7 p.m. Saturday and Sunday.

Supplemental employees will be paid the straight time rate for the job they are filling in for as per Schedule "A". They will be scheduled weekly to supplement operational and cleaning requirements and will be guaranteed at least sixteen (16) hours of work per weekend.

Supplemental weekend employees will not be eligible to work Monday to Friday without agreement with the Union.

Staffing Compliment

Full-time bargaining unit employees will be offered Saturday and Sunday production overtime first. A maximum of 6 Supplemental Weekend Employees shall perform work on any weekend. Available supplemental Weekend Workers shall be scheduled prior to any full-time bargaining unit employees being forced to work Saturday or Sunday production overtime. If no additional production overtime is available after the initial canvass of full-time bargaining unit employees, the Supplemental Weekend Employees will perform cleaning.

Supplemental employees will be laid off prior to any full-time employee being placed either on temporary or permanent

layoff.

Probationary Period

No seniority rights are recognized during the first 720 hours of regularly scheduled time. This will be the probationary period of any new supplemental weekend employees. On completion of the probationary period, the seniority date shall extend back to date of hire. Upon completion of the probationary period, these employees shall become members of the Union in accordance with Article 6 of the Collective Agreement.

Job Transfers

Job openings shall be posted twelve (12) days in advance of the permanent filling of any vacancy or newly created job. The Company agrees to fill positions in order of seniority, subject to the individual's qualifications.

Compensation

Supplemental weekend employees will be paid in accordance with Schedule "A" of the Collective Agreement.

Supplemental weekend employees reporting for work who failed to receive notice not to report and receives less than four (4) hours of work shall be paid not less than four (4) hours pay at the employee's normal straight-time hourly wage rate. An employee called in at a time other than his/her regular shift by reason of emergency work shall receive at least four (4) hours pay at the straight-time rate if called in on Saturday or Sunday.

Lunch and break periods when working 12 hours will include two (2) thirty (30) minute meal periods and one (1) fifteen (15) minute break period at times determined by the Company.

Lunch and break periods when working 8 hours will include one (1) thirty (30) minute meal period and two (2) fifteen (15) minute break period at times determined by the Company.

Benefits

The Company will provide the same benefits to supplemental weekend employees as it does to regular employees, except the pension benefit will be pro-rated based on their abbreviated work week.

Holiday Pay

Supplemental weekend employees will receive eight (8) hours pay at their straight-time hourly rate for nine (9) statutory holidays, namely, New Year's Day, Family Day, Good Friday, Victoria Day, Canada Day, Labour Day, Thanksgiving Day, Christmas Day, and Boxing Day. Should a holiday fall on Saturday or Sunday and these employees are required to work, they will receive pay for all hours worked at time and one half in addition to holiday pay. The normal holiday eligibility requirements of the Collective Agreement shall apply.

Vacation

Supplemental weekend employees will be entitled to have vacation time paid as per the ESA.
